You are hereby notified that the Planning and Land Use Management (PLUM) Committee of the Los Angeles City Council will hold a public hearing **telephonically** on **Tuesday, August 16, 2022** at approximately **2:00 P.M.**, or soon thereafter, to consider the following: Categorical Exemption from the California Environmental Quality Act (CEQA) pursuant to Article 19, Section 15332 (Class 32) of the CEQA Guidelines, and related CEQA findings; report from the North Valley Area Planning Commission (NVAPC), and an Appeal filed by Supporters Alliance for Environmental Responsibility (SAFER), from the determination of the NVAPC in approving a Categorical Exemption as the environmental clearance for a project involving the construction of a new 309,169-square-foot, five-story, 350-unit multi-family residential building, and a new six-level, 466-stall above-grade automobile parking garage, for the property located at 9450 North Shirley Avenue.
