**SUBJECT: LA SANITATION AND ENVIRONMENT RESPONSE TO FY 2025-26
PROPOSED BUDGET**

LASAN greatly appreciates Mayor Bass' commitment to preserving core services as the City continues to face very challenging financial conditions that will necessitate very difficult decisions and paradigm shifts in the way the City delivers services.

Thank you for the opportunity to provide our input regarding the resources allocated to LASAN by the Mayor's Proposed Budget. LASAN's top-line core services include:

- Clean Water Program – conveyance and treatment of wastewater for 4 million residents and 29 contract cities
- Watershed Protection – beneficial management of the City's watersheds
- Solid Waste Management – collection and disposal of solid refuse for approximately 743,000 customers
- Livability Services – targeted programs to improve citywide cleanliness

The Proposed Budget provides much needed resources in support of our Clean Water Program to address deferred maintenance and the restoration of positions at our water reclamation plants and conveyance system, as well as operation and maintenance support for our watershed investments.

The Proposed Budget also includes the elimination of 238 positions (159 filled authorities and 79 vacant authorities). Citywide Recycling Trust Fund (1), Stormwater Pollution Abatement Fund (20), and General Fund (217) currently fund the eliminated positions. LASAN is aware that there has been hiring and attrition since the time these eliminations were identified and requests authority to internally reconcile filled and vacant positions at the appropriate time during the budget process. To the greatest extent possible and where appropriate, LASAN will make every effort to accommodate displaced employees within existing vacant authorities.

These position deletions will result in the total elimination or significant reduction of several critical programs:

- Street Receptacle Collections

- Regional Storage Facility
- Mobile Hygiene Operations
- Brownfields
- Biodiversity and Healthy Soils
- Climate Action
- Clean Up Green Up

The Proposed Budget includes the elimination of the Division Manager (Principal Environmental Engineer) and Assistant Division Manager (Senior Environmental Engineer) positions for the Watershed Protection Division (WPD). These positions currently have employees acting in the roles. The proposed deletions would leave the Division with no management to direct the work of employees in compliance of the MS4 requirements. Ten additional positions have also been identified for deletion in WPD. These positions implement the MS4 stormwater permit and include two Environmental Compliance Inspectors that perform required facility inspections and investigate illicit discharges, and are also trained to provide illegal dumping enforcement when supplemental funding is provided. Offset revenue has been proposed to restore all 12 positions as further discussed in **ATTACHMENT A**.

The elimination of positions supporting the Low Impact Development (LID) program, which are fee-supported, revenue-generating positions, will delay critical permitting processes for the Palisades rebuilding effort as well as affordable housing throughout the City.

The Proposed Budget will drastically reduce the resources available for CARE/CARE+ services and Illegal Dumping. This includes the elimination or downsizing of: Mobile Hygiene Operations, A Bridge Home/DTLA CARE/+, LA River CARE team, Coastal and Hollywood teams, Illegal Dumping Alt Shift Teams, and MacArthur Park operations. LASAN provides alternatives below for your consideration.

In response to Mayor Bass' proposed budget LSD has drafted a division restructuring proposal. This proposal includes a deletion of a total of 164 positions in the LSD Environmental Quality (EQ) and Street Hygiene divisions. The goal of this proposal is to maintain all critical and core services.

The impacts of these reductions include the following:

- LASAN will be unable to achieve the goal of 5 days of CARE+ for each Council District and Focused Service Zones will be negatively affected;
- Reduced OT will directly impact the ability of staff to respond to unscheduled work.
- The Mobile Hygiene program will be eliminated;
- Reduction in Illegal Dumping teams from 26 to 16 and a reduction in service days from seven to five; and
- Negatively impact our tonnage, trash and hazardous materials collected

CARE/CARE+

Currently LSD has 26 CARE+ Teams. The Mayor's Proposed Budget would maintain 15 Teams (one for each Council District). LASAN is proposing to maintain 17 Teams which would be achieved by consolidating two specialty teams. The impacts of this reduction would limit provision of CARE+ service to two days a week in each Council District.

Additional recommendations include the deletion of vacant positions to All CARE/CARE+ A Bridge Home Teams; LA River Team; Hollywood Team; DTLA Team, and consolidate the Grand Ave and Coastal CARE+ Teams. Operation Healthy Streets Skid Row, and the Council District-based CARE Teams will remain.

Retaining the 21 Administrative Support positions will allow the group to continue to provide support to both of the divisions with no disruption to services. Also retaining the GIS/Data Support Section will also allow LASAN to maintain and optimize critical workflows,

Illegal Dumping Program

LASAN is proposing for the The Illegal Dumping Program to be restructured to 16, two-person teams (16 RCTOs and 16 MLs). The program will also move from 7-days a week to a 5-days week operation to ensure proper and adequate oversight.

Receptacle Program

Automated Litter Bin (ALB) Section will be reduced from 10 to 6 RCTO positions, the minimum required to continue providing citywide service with strategic adjustments to routing and service frequency. Maintaining all 26 ML positions is critical to operating the program as designed, using paired teams, while meeting the demands of a 7-day collection schedule.

LASAN also proposes several technical changes to adjust funding sources for certain positions, including a GIS position for Wastewater Engineering Services, two Service Coordinators for the Executive Division, and two positions for the Administration Division.

Compounded by the previous Fiscal Year's deletions of vacant authorities, it will not be possible to maintain current service levels in several areas as further discussed in **ATTACHMENT A**. Pursuant to your instructions, also attached is LASAN's organizational chart annotated to reflect position eliminations **ATTACHMENT B**.

LASAN is aware of potential reductions proposed for General Services, Bureau of Engineering and Bureau of Contract Administration that may negatively impact the Clean Water and Watershed Protection Programs and requests consideration of those impacts in alignment with LASAN when those bureaus are evaluated.

In addition to the position eliminations described here, LASAN's salary, contractual services and overtime funding were also severely reduced. Along with the deletion of vacancies, these factors will seriously hamper LASAN's ability to respond to unplanned and emergency-related work.

Thank you for your consideration of our requested changes.


