I am in receipt of the notice of hearing dated December 20, 2024. Please accept this letter as my formal letter of protest regarding the storage container violation dated August 7, 2019.

I have read the attached order to comply and notice of fee dated August 7, 2019, and respond as follows:

first, I apologize, I was not aware I had a fine to pay for the storage pod. My husband, speaks very little English, what I recall he told me was that we had to remove the container immediately or the City of Los Angeles would issue a violation. I called and had the storage pod removed immediately, within a few days from the date my husband said the City inspector requested the removal. My husband's understanding of the English language is minimal. He got by, but that was it. He no longer lives in the country. He now resides in Mexico.

I did not receive a copy of the letter attached to the Notice of Hearing, nor did I ever see the violation or notice of violation. My recollection is that an inspector came by the house as asked that the pod be removed immediately or else. The storage pod was removed immediately and I was under the impression that was the end of the issue. Pursuant to the Notice, a call had to be made to inform the City the violation was cured. I am sure, my husband did not understand or know he had to call the City to report the pod was removed and violation cured. He thought he received a warning from the inspector. The pod was removed immediately.


I am a single parent, I have one child in college and one child in high school. I have a one income home and my home is all I have. In the year 2024, I spent the majority of the year on disability, I had five surgeries and am continuing treatment.

It was an error, ignorance, excusable neglect, and a mistake that the violation was not paid. I did not have the privilege of receiving, viewing or reading the violation, as I did not know a violation had been issued. As mentioned above, my understanding is that an inspector requested the immediate removal of the pod and that was done.

I respectfully request that you please do not place a lien on my home, and that under the circumstances outlined above, the council accept my protest as submitted and that the fine be waived or reduced.
