An ordinance amending Section 103.12 of Division 4, Article 3, Chapter X of the Los Angeles Municipal Code to revise the Business Permit Fee Schedule.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. The Business Permit Fee Schedule of Section 103.12, Division 4, Article 3, Chapter X of the Los Angeles Municipal Code is amended to read as follows:
