

COMMUNICATION FROM CHAIR, TRANSPORTATION COMMITTEE, and RESOLUTION (RODRIGUEZ FOR BLUMENFIELD – LEE) relative to establishing oversize vehicle parking restrictions along certain street segments of Sherman Way, Winnetka Avenue, Glade Avenue, Elkwood Street, and Saticoy Street, in Council District Three (CD 3).

Recommendation for Council action, pursuant to Resolution (Rodriguez for Blumenfield – Lee):

RESOLVE to:

1. PROHIBIT, pursuant to Los Angeles Municipal Code Section 80.69.4, the parking of vehicles that are in excess of 22 feet in length or over seven feet in height, during the hours of 2:00 a.m. and 6:00 a.m., along the following street segments:
  - a. Sherman Way between De Soto Avenue and Mason Avenue
  - b. Winnetka Avenue between Roscoe Boulevard and Keswick Street
  - c. Glade Avenue between Elkwood Street and Saticoy Street
  - d. Elkwood Street between Glade Avenue and Topanga Canyon Boulevard
  - e. Saticoy Street between De Soto Avenue and Lurline Avenue
2. DIRECT the Los Angeles Department of Transportation (LADOT), upon adoption of this Resolution, to post signs giving notice of a “tow away, no parking” restriction for oversize vehicles, with the specific hours detailed, at the above locations.
3. AUTHORIZE the LADOT to make technical corrections or clarifications to the above instructions in order to effectuate the intent of this Resolution.

Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

Summary:

On December 4, 2024, your Transportation Committee considered a Resolution (Rodriguez for Blumenfield – Lee) relative to establishing oversize vehicle parking restrictions along certain street segments of Sherman Way, Winnetka Avenue, Glade Avenue, Elkwood Street, and Saticoy Street, in CD 3, as detailed in the Resolution and

in Recommendation No. 1 above. According to the Resolution, there is an increased problem with oversized vehicles that park overnight along several street segments where these large vehicles are often parked overnight and immediately adjacent to residential buildings, which constricts travel lanes and creates dangerous situations. Pursuant to LAMC Section 80.69.4, it is proposed that the parking of vehicles that are in excess of 22 feet in length or over seven feet in height, during the hours of 2:00 a.m. to 6:00 a.m., be prohibited along the street segments as detailed in Recommendation No. 1. After consideration and having provided an opportunity for public comment, the Committee recommendation to approve the Resolution failed. This matter is now submitted to Council for its consideration.
