Fund the Public Bank Feasibility Study. On behalf of over 70 organizations who have signed on to the attached budget request letter from the Public Bank LA Coalition, we urge the Council to fund the public bank feasibility study. Los Angeles faces urgent financial challenges, including budget shortfalls, wildfire recovery, and federal uncertainty, making long-term financing more critical than ever. The City of LA pays \$1.4 billion annually in debt service, including over \$300 million in interest and fees annually to Wall Street banks and financial firms. These are funds that could instead be invested locally to build affordable housing, support small businesses, repair roads, and strengthen climate resilience. We need a plan to give the city a tool to save money, lower borrowing costs, and keep public funds working for Angelenos. Fund the Public Bank Feasibility Study and give Los Angeles a roadmap to reinvest in its people.
