Subject: RESOLUTION NO. 24-10413: SECOND AMENDMENT TO REIMBURSEMENT AGREEMENT NO.
19-3706 WITH THE SAN PEDRO PUBLIC MARKET, LLC

Pursuant to Section 373 of the City Charter and Section 10.5 of the Los Angeles Administrative Code; enclosed for your approval is Resolution No. 24-10413 for the proposed Second Amendment to the San Pedro Public Market, LLC (SPPM) Reimbursement Agreement No. 19-3706 (Agreement) to reimburse the City of Los Angeles Harbor Department (Harbor Department) 100% of staff and consultant costs associated with the preparation of an environmental assessment for proposed modifications associated with the West Harbor (formerly known as San Pedro Public Market) Modification Project. The proposed Second Amendment would extend the duration of the existing Agreement by an additional two years, from five years to seven years, as proposed. No other modifications are proposed. SPPM will continue to be financially responsible for these expenditures. There is no impact to the General Fund.

RECOMMENDATION FOR CITY COUNCIL:

1. ADOPT the determination by the Board of Harbor Commissioners that the proposed action is administratively exempt from the requirements of the California Environmental Quality Act (CEQA) under Article II, Section 2(f) of the Los Angeles City CEQA Guidelines and;
2. APPROVE POLA Resolution No. 24-10413 for the proposed Second Amendment to Agreement No. 24-3706-B between the City of Los Angeles Harbor Department and The San Pedro Public Market, LLC.
