

RESOLUTION NO. 27270

WHEREAS, on recommendation of Management, there was presented for approval, First Amendment to Contract DA-5300 with Motorola Solutions Inc. to extend the term through October 31, 2023, covering ongoing radio system maintenance, repair, and technical support services for the Trunked Radio Communications System of Los Angeles World Airports; and

WHEREAS, Los Angeles World Airports (LAWA) uses the Trunked Radio Communications System (Trunked Radio System) for airport safety, security, and operations. The Trunked Radio System consists of 700 MHz and 400 MHz trunked systems and associated portable and mobile radio units. The Trunked Radio System is used by approximately 2,000 personnel from Airport Police Division, Airport Operations Division, Facilities Maintenance Division, and other LAWA Divisions, for radio communications; and

WHEREAS, LAWA completed the Trunked Radio System Upgrade capital project at Los Angeles International Airport (LAX) and Van Nuys Airport (VNY) in October 2020. The project included upgrades to the 700 MHz system to enable LAWA to use the 700 MHz National Interoperability Public Safety frequency range that was established as part of a nationwide first responder public safety network; and

WHEREAS, LAWA also exercised the contract option to subscribe to the Wide Area Voice Environment (WAVE) cloud-based service of Motorola Solutions Inc. (Motorola) and purchase additional radio units for the Airport Operations Division to improve radio communications between LAWA business units. The WAVE mobile application will make radio services available on LAWA cellphones for use by various LAWA key personnel; and

WHEREAS, Motorola's maintenance services to be provided under the First Amendment will include 24x7x365 technical support, including monitoring of the radio network, onsite support, preventive maintenance, security patch updates, and repair and replacement of inoperable field equipment. Maintenance services will begin November 1, 2021; and

WHEREAS, the First Amendment will ensure continuity of the maintenance, repair, and technical support services for the Trunked Radio System until a new contract is awarded through completion of a Request for Proposals process. There is sufficient authority remaining to cover the cost of the maintenance services through October 31, 2023; and

WHEREAS, following is a summary of the current expenditures under the contract:

WHEREAS, the estimated services and expenditures under the Amendment are as follows:

WHEREAS, funds for the contract are being identified in the Fiscal Year 2021-2022 LAWA Operating Budget in LAX Cost Center 1170202 – IT Planning & Development, Commitment Item 520 – Contractual Services and Commitment Item 522 – Materials & Supplies. Funding for subsequent years will be requested as part of the annual budget process; and

WHEREAS, this item, as a continuing administrative, maintenance and personnel-related activity, is exempt from California Environmental Quality Act (CEQA) requirements pursuant to Article II, Section 2.f. of the Los Angeles City CEQA Guidelines; and

WHEREAS, Motorola is required by contract to comply with the provisions of the Service Contractor Worker Retention and/or Living Wage Ordinance; and

WHEREAS, Procurement Services reviewed this action (File 8584). No mandatory Small Business Enterprise (SBE), Local Business Enterprise/Local SBE, and Disabled Veterans Business Enterprise goals for the project have been set, as no subcontracting opportunities were identified. However, Motorola pledged to 10% SBE participation and has achieved 0.388% to date; and

WHEREAS, Motorola is required by contract to comply with the provisions of the Affirmative Action Program; and

WHEREAS, Motorola is assigned Business Tax Registration Certificate 0000749148-0001-7; and

WHEREAS, Motorola is required by contract to comply with the provisions of the Child Support Obligations Ordinance; and

WHEREAS, Motorola has approved insurance documents, in the terms and amounts required, on file with LAWA; and

WHEREAS, pursuant to Charter Section 1022, staff determined that the work specified on the contract can be performed more feasibly or economically by an Independent Contractor than by City employees; and

WHEREAS, Motorola has submitted the Contractor Responsibility Program Questionnaire and Pledge of Compliance, and will comply with the provisions of said program; and

WHEREAS, Motorola must be determined by Public Works, Office of Contract Compliance, to be in compliance with the provisions of the Equal Benefits Ordinance prior to execution of the First Amendment; and

WHEREAS, Motorola will be required to comply with the provisions of the First Source Hiring Program for all non-trade LAX jobs; and

WHEREAS, Motorola has submitted the Bidder Contributions CEC Form 55, and will comply with its provisions; and

WHEREAS, Motorola has submitted the MLO Bidder Contributions CEC Form 50, and will comply with its provisions; and


WHEREAS, Motorola will comply with the provisions of the Iran Contracting Act; and

WHEREAS, actions taken on this item by the Board of Airport Commissioners will become final pursuant to the provisions of Los Angeles City Charter Section 373;

NOW, THEREFORE, BE IT RESOLVED that the Board of Airport Commissioners adopted the Staff Report; determined that this action is exempt from the California Environmental Quality Act (CEQA) pursuant to Article II, Section 2.f. of the Los Angeles City CEQA Guidelines; found that the work can be performed more economically or feasibly by an independent contractor than by City employees; further found that, pursuant to Los Angeles Administrative Code Section 10.15(a)(10) and Los Angeles City Charter Section 371(e)(10), the services to be provided under the contract involve performance of professional, expert, technical and other special services such that use of competitive bidding would be impractical and undesirable; approved the First Amendment to Contract DA-5300 with Motorola Solutions Inc. to extend the term through October 31, 2023, covering ongoing radio system maintenance, repair, and technical support services for the Trunked Radio Communications System of Los Angeles World Airports; and authorized the Chief Executive Officer to execute said First Amendment to Contract DA-5300 with Motorola Solutions Inc. after approval as to form by the City Attorney and approval by the Los Angeles City Council.
