Re: **CF 21-0777-S1; WRAC Policy – Oppose Misuse of Specific Plan Process**

Honorable City officials:

The Westside Regional Alliance of Councils (WRAC) is a coalition of all fourteen neighborhood and community councils on the Westside of Los Angeles, located in CDs 5 and 11 and portions of CDs 4 and 10.

In connection with the above-referenced Council File, we wish to advise City officials of our Alliance's official policy position, held since May 2022: **WRAC opposes the use of Specific Plans that would result in upzoning open space and/or low-density residential neighborhoods:**

"The Westside Regional Alliance of Councils opposes the City's use of Specific Plans that would result in upzoning open space and/or low-density residential neighborhoods. The use of specific plans in this manner creates significant negative impacts for all residential communities, the environment and natural resources. We urge our City Councilmembers to reject land use applications for individual development projects that represent a misuse of the Specific plan process. We ask that the City Council inform Planning not to process these types of requests."

Although WRAC has not taken a specific position on the motion by Councilwoman Katy Yaroslavsky in CF 21-0777-S1, or on the Benedict Canyon hotel project which is the subject of CF 21-0777-S1 (the Project), we emphasize that:

- 1) Project implementation would require a General Plan Amendment with a Vesting Zone Change (VZC) to upzone the site zoning in the Benedict Canyon Specific Plan (from Very Low and Minimal Residential density to High-Medium Residential density);
- 2) the requested General Plan Amendment is opposed by Bel Air-Beverly Crest Neighborhood Council (one of WRAC's respected Member councils and the neighborhood council which represents the area where the Project would be sited); and
- 3) the requested General Plan Amendment (with a VZC to upzone the site zoning) appears to be directly contrary to WRAC's official policy position.
