INDEPENDENT CONTRACTOR AGREEMENT

This agreement is entered into as of 9-19-2023, between Hi Lite Motel, hereafter referred to as the Company, and ENFORCER PATROL SERVICE, hereafter referred to as the Contractor.

Subject to the terms and conditions of this Agreement, the Company, hereby engages the Contractor, Woolery Assurance Services as an independent contractor to perform the services set forth herein, and the Contractor hereby accepts such engagement.

Duties, Terms, and Compensation. The Contractor's duties, term of engagement, compensation and conditions for payment thereof shall be as set forth in this agreement and estimate previously agreed to by the Company and the Contractor, which may be amended in writing from time to time, or

supplemented with subsequent estimates for services to be rendered by the Contractor and agreed to by the Company, and which collectively are hereby incorporated by reference. *Contractor will provide Patrol Service for the agreed upon location(s); Service will be nightly and when requested, trouble shooter during the day from 11am to 1pm. This service will be provided at a rate of \$200.00 per month, payable upon receipt of the presentation of an approved invoice from the contractor. Invoice will be payable upon receipt. This service will continue until terminated by the Company or the Contractor.*

Payments. During the term of this Agreement, the Contractor shall bill and the Company shall reimburse the Contractor for all invoices provided to the Company.

Monthly Reports. The Company may request that reports be provided by Contractor on a monthly basis.

Such reports shall be in such form and setting forth such information and data as is reasonably requested by the Company.

Confidentiality. The Contractor acknowledges that during the engagement [he or she] will have access to and become acquainted with various trade secrets, inventions, innovations, processes, information, know-how, and specifications owned or licensed by the Company and/or used by the Company in connection with the operation of its business including, without limitation, the Company's business and product information, methods, customer lists, accounts and procedures. The Contractor agrees that [he or she] will not disclose any of the aforesaid, directly or indirectly, or use any of them in any manner, either during or after the term of this Agreement or at any time thereafter, except as required in the course of this engagement with the Company. All files, records, documents, blueprints, specifications, information, letters, notes, and lists, original artwork/creative, notebooks, and similar items relating to the business of the Company, whether prepared by the Contractor or otherwise coming into [his or her] possession, shall be the confidential property of the Company. The Contractor shall not retain any copies of the foregoing without the Company's prior written permission. Upon the expiration or earlier termination of this Agreement, or whenever requested by the Company, the Contractor shall immediately deliver to the Company all such files, records, documents, specifications, information, and other items in [his or her] possession or under [his or her] control. The Contractor further agrees that [he or she] will not disclose any information retained as an independent contractor or the terms of this Agreement to any person without the prior written consent of the Company and shall at all times preserve the confidential nature of [his or her] relationship to the Company and of the services hereunder.

Conflicts of Interest, Non-hire Provision. The Contractor represents that [he or she] is free to enter into this Agreement and that this engagement does not violate the terms of any agreement between the Contractor and any third party. During the term of this agreement, the Contractor shall devote as much of [his or her] productive time, energy and abilities to the performance of [his or her] duties hereunder as is necessary to perform [he] required duties in a timely and productive manner. The Contractor is expressly prohibited from performing services for other parties while performing services for the Company.

14.11. This Agreement shall not be terminated by the merger or consolidation of the Company into any other entity.

14.12. The Company may terminate this Agreement at any time by 10 working days' written notice to the Contractor. In addition, if the Contractor is convicted of any crime or offense, fails or refuses to comply with the written policies or reasonable directive of the Company, is guilty of serious misconduct in connection with performance hereunder, or materially breaches provisions of this Agreement, the Company at any time may terminate the engagement of the Contractor immediately and without prior written notice to the Contractor.

14.13. Independent Contractor. This Agreement shall not render the Contractor an employee, partner, agent or joint venture with the Company for any purpose. The Contractor is and will remain an independent contractor in this or any other relationship to the Company. The Company shall not be responsible for withholding taxes with respect to the Contractor's compensation hereunder. The Contractor shall have no claim against the Company hereunder or otherwise for vacation pay, sick leave, retirement benefits, health security, worker's compensation, health or disability benefits, unemployment insurance benefits, or employee benefits of any kind.

14.14. Successors and Assigns. All of the provisions of this Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective heirs, if any, successors, and assigns.

14.15. Choice of Law. The laws of the state of California shall govern the validity of this Agreement, the construction of its terms and the interpretation of the rights and duties of the parties hereto.

14.16. Arbitration. Any controversies arising out of the terms of this Agreement or its interpretation shall be resolved in California in accordance with the rules of the American Arbitration Association, and the judgment upon award may be entered in any court having jurisdiction thereof.

14.17. Headings. Section headings are not to be considered a part of this Agreement and are not intended to constitute an accurate description of the contents hereof.

14.18. Waiver. Waiver by one party hereto of breach of any provision of this Agreement by the other shall constitute a continuing waiver.

14.19. Notices. Any and all notices, demands, or other communications required or desired to be given hereunder by any party shall be in writing and shall be validly given or made to another party if personally served, or if deposited in the United States mail, certified or registered, postage prepaid, return receipt requested. If such notice or demand is served personally, notice shall be deemed constructively made at the time of such personal service. If such notice, demand or other communication is given by mail, such notice shall be conclusively deemed given five days after deposit thereof in the United States mail addressed to the party to whom such notice, demand or other communication is to be given as follows:

To the Contractor:

14.20. Modification or Amendment. No amendment, change or modification of this Agreement shall be valid unless in writing signed by the parties hereto.

14.21. Entire Understanding. This document and any exhibit attached constitute the entire understanding and agreement of the parties.

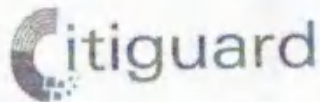

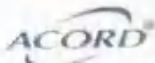

MEMORANDUM OF UNDERSTANDING

This Agreement for Professional Security Services, hereafter referred as the "Agreement", effective JUNE 1, 2014 and made between the **Metropolitan Office of Public Safety, Inc. (MOPS)** a California Private Patrol Corporation, with its principal office at 221 W. 94th St. Los Angeles, Ca. 90003 and L.A. HILITE PROPERTY INC. DBA: HILITE MOTEL ("hereinafter Client").

This "AGREEMENT FOR PATROL SERVICES" will stay in effect on a Month to Month basis until the **Metropolitan Office of Public Safety** In lieu of an established agreement, this Agreement will be on a month to month basis and will be effective on JUNE 1, 2014 and will be for the purpose of providing public safety Patrol services.

RECITALS

I. Services

Observe and Report Duties:

The terms "observe and report" shall include the duties of the **Metropolitan Office of Public Safety** "Public Safety Officer" and are limited to: PATROL SERVICE: FROM 6:00PM TO 4:00AM, THREE (3) PATROL VISITS PRE NIGHT, SEVEN (7) DAYS A WEEK PLUS UNLIMITED RESPONSES AT NO ADDITIONAL CHARGES.

Providing a visible deterrent to deter against property crimes and crimes against people, graffiti, robbery, burglary, trespassing, truancy, assaults, fights, misapplication of property; the terms are limited to the property of the client, so long as the property is located within the geographical area of 10321 S. BROADWAY, LOS ANGELES, CA. 90003. However, if observing and reporting fails to prevent any incidents mentioned above then **Metropolitan Office of Public Safety** shall not be held liable under the terms of this agreement for any damages of persons or property, loss of life. MOPS will alert the proper law enforcement authorities of any criminal incident immediately. Attached is a scope for additional services.

II. Billing

Metropolitan Office of Public Safety will bill the **Client** at a rate of **\$100.00 per Month**
ALSO A \$100.00 SERVICE RETAINER IS REQUIRED BEFORE START OF SERVICE.

III. Payment and Invoicing Terms

The **Client** shall, upon receiving an invoice from **Metropolitan Office of Public Safety**, make payment payable to **Metropolitan Office of Public Safety**. Payment shall be due on a net 5 day period.

IV. Late Payment Policy

Client shall be liable for late payments charges for payments received more than 10 days from due date. A late fee of \$35.00 will be added to any unpaid invoice due by more than 10 days. Failure to pay any invoice within 15 days of the due date will result in a possible termination of this agreement. Non-payment of any invoice does not release the client from any amount due at the time of termination. All amounts due plus late charges, if any, will be referred to an outside collection agency and law firm for collection.

V. Termination

This agreement will stay in effect until the **Metropolitan Office of Public Safety** receives a written termination letter by the client. Via E-mail or U.S. Postal Mail.

VI. Notices

Client shall give **Metropolitan Office of Public Safety** written notice within one hundred eighty (180) days, or sooner, of obtaining knowledge of the occurrence of any claim or cause of action which **Client** believes that it has, or may seek to assert or allege, against **Metropolitan Office of Public Safety**, whether such claim is based in law or equity, arising under or related to this Agreement or to the transactions contemplated hereby, or any act or omission to act by **Metropolitan Office of Public Safety** with respect hereto. If **Client** fails to give such notice to **Metropolitan Office of Public Safety** with regard to any such claim or cause of action and shall not have brought legal action for such claim or cause of action within said time period, **Client** shall be deemed to have waived, and shall be forever barred from bringing or asserting such claim or cause of action in any suit, action or proceeding in any court or before any governmental agency or authority or any arbitrator. All notices and/or other communications hereunder shall be in

Assignment:

The Agreement is not assignable or transferable by **Client**, except as agreed by both parties in writing. This Agreement is not assignable or transferable by **Metropolitan Office of Public Safety** without the written consent of **Client**, which consent shall not be unreasonably withheld or delayed.

Disputes:

Metropolitan Office of Public Safety and the **Client** recognize that disputes arising under this Agreement are best resolved at the working level by the parties directly involved. Both parties are required to attempt to resolve any dispute. Such efforts shall include the referral of any remaining issues in dispute to higher authority within each participating party's organization for resolution.

Failing resolution of conflicts at the organizational level, **Metropolitan Office of Public Safety** and **Client** agree that any remaining conflicts arising out of or relating to this Contract shall be submitted to non-binding mediation unless **Metropolitan Office of Public Safety** and **Client** mutually agree otherwise. If the dispute is not resolved through non-binding mediation, then the parties may take other appropriate action subject to the other terms of this Agreement.

This Agreement may be executed (by original or tele-copied signature) in counterparts, each of which shall be deemed an original, but all of which taken together shall constitute but one and the same instrument.

Non-solicitation of Employees:

During or after the life term of this Agreement, Client will not solicit the employment of, or employ Metropolitan Office of Public Safety personnel (Resource Officers), without the Metropolitan Office of Public Safety prior written consent. Client will be financially responsible for the training and other work related investment of a MOPS Public Safety Officer.

Governing Law and Construction:

This Agreement will be governed by and construed in accordance with the laws of the California, without regard to the principles of conflicts of law. The language of this Agreement shall be deemed to be the result of negotiation among the parties and their respective counsel and shall not be construed strictly for or against any party.

Arbitration:

Any controversy, dispute or claim arising out of or related to this Agreement or breach of this Agreement shall be settled solely by confidential binding arbitration by a single arbitrator in accordance with the arbitration rules of the American Arbitration Association (AAA) in effect at the time the arbitration commences. The award of the arbitrator shall be final and binding. No party shall be entitled to, and the arbitrator is not authorized to, award legal fees, expert witness fees, or related costs of a party. The arbitration shall be held in a location agreed upon by both the parties.

Entire Agreement; Survival:

This Agreement, including any Exhibits, states the entire Agreement between the parties and supersedes all previous contracts, proposals, oral or written, and all other communications between the parties respecting the subject matter hereof, and supersedes any and all prior understandings, representations, warranties, agreements or contracts (whether oral or written) between Client and Metropolitan Office of Public Safety respecting the subject matter hereof. 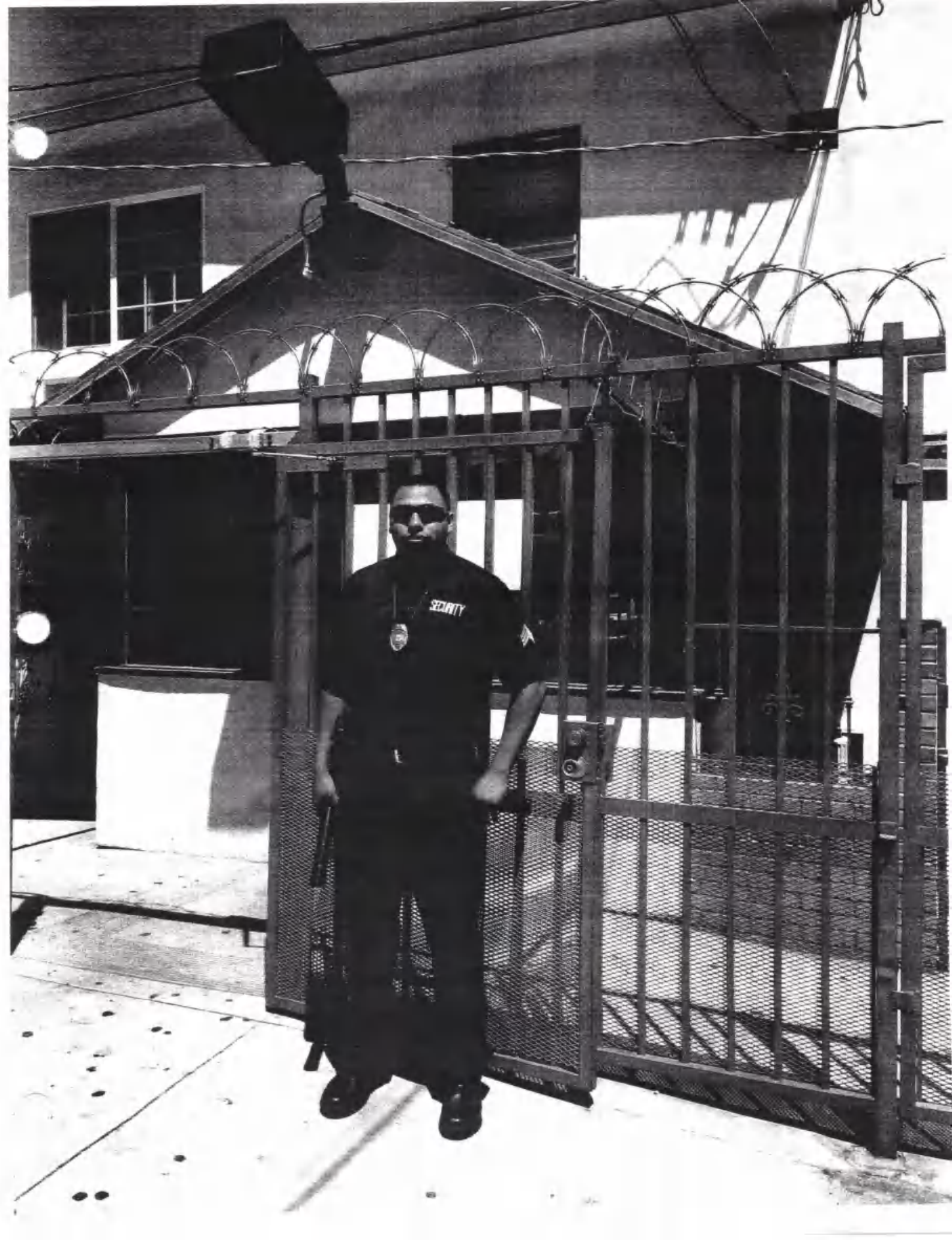

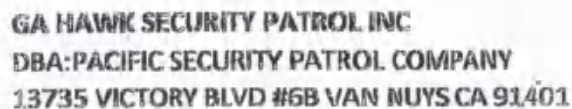
