Comments for Public Posting: Hi Mayor Bass, We are happy residents and homeowners in Sunland-Tujunga and are very opposed to the proposed sewer rate increase (CF 23-0600-S9) and ask you to please vote no if the proposal comes across your desk. I received the pamphlet from LADWP a few months ago and it contains no information about their plan and how they intend to spend the exorbitant amount of money they will get from the rate increase. We already pay a lot in taxes as property owners and hidden fees in our utility bills. A 200% rate increase overnight and then every quarter is outrageous. We cannot afford that, and it's unfair to expect us to accept this without more information. I'd appreciate information released by the utility company for these questions: -Will my family in 91040 benefit from these new projects or are these for new developments outside of my neighborhood? -What is the timeline for the projects to ensure they don't come back in 4 years demanding more money? -Who is overseeing these upgrades and keeping the vendors accountable and on schedule? I work in project management and it is very common to get off budget. -If there are savings on project completion, will that return to citizens in some form? Let's incentivize these vendors to come in under budget and earlier than scheduled. Withhold money until project is done. Please vote no on the sewer rate change. This is not the right time for a cost increase for my neighbors in LA, and LADWP should do better to adopt a more aggressive budget.
