RECOMMENDATIONS FOR CITY COUNCIL:

1. Adopt the determination by said Board that this action is exempt from the California Environmental Quality Act (CEQA) pursuant to Article II, Section 2.i of the Los Angeles City CEQA Guidelines; and
2. Further adopt the determination by said Board that the action does not require review under CEQA pursuant to Public Resources Code Section 21166 and CEQA Guidelines Sections 15162 and 15168 as it does not include any changes to the Los Angeles International Airport (LAX) Midfield Satellite Concourse (MSC) Program that would result in significant impacts not already disclosed in the Environmental Impact Report (EIR) prepared for the LAX MSC [SCH# 2013021020], which was certified by said Board on July 21, 2014 (Resolution 25478), and certified and adopted by the Los Angeles City Council on August 20, 2014, and found that this action is, therefore, within the scope of the prior MSC EIR; and
3. Approve the First Amendment to Contract DA-5383 with Woods Bagot Architects, PC, to extend the term through September 2, 2025, covering design services for the Midfield Satellite Concourse South Project at Los Angeles International Airport; and
4. Concur with said Board's action on July 21, 2022, by Resolution 27546, authorizing the Chief Executive Officer, or designee, of Los Angeles World Airports to execute said First Amendment to Contract DA-5383 with Woods Bagot Architects, PC.
