**RE: UNCLAIMED MONIES SEIZED INCIDENTAL TO ARREST TRUST FUND**

Dear Honorable Members:

On May 8, 2023, the Los Angeles Police Department (LAPD) requested an escheatment of \$363,274.53 from the Unclaimed Monies Seized Incidental to Arrest Trust Fund (Fund No. 7772 UMSIATF) to the City's General Fund. This money has remained unclaimed for three years and is therefore eligible for transfer in accordance with the notification requirements of the City of Los Angeles Administrative Code Section 5.112 and current state law.

**BACKGROUND**

The State of California Government Code Section 50050-50055 provides that any money remaining unclaimed in the City Treasury for three years or more may become the property of the City after publication of a notice, provided that within the specified period of time, no verified complaint seeking to recover all or a designated part of the money is filed in a court of competent jurisdiction.

Attached herewith is LAPD's request to escheat monies from Fund No. 7772 dated May 8, 2023, the Office of the City Clerk's proof of publication advertisements dated August 10, 2023 and the subsequent notice and publications executed on August 17, 2023. These notices stated that on October 6, 2023, funds seized from July 27, 2017 through April 3, 2020 would become property of the City. As of the respective aforementioned dates, one claim in the amount of \$29.92 has been processed. Per the City Council's instructions (CF No. 04-2206-S1), the Office of Finance has reviewed the escheatment eligibility and publication notices.



**RECOMMENDED ACTION**

In accordance with the authority of the State Government Code and City of Los Angeles Administrative Code, it is recommended that City Council, subject to approval of the Mayor, should:

1. INSTRUCT the Los Angeles Police Department and the City Treasurer to process the sum of \$363,244.61 from the Unclaimed Monies Seized Incidental to Arrest Trust Fund No. 7772; and
2. REQUEST the Controller to TRANSFER all identified eligible monies to the General Fund, Fund No.100, Department 70, Revenue Source Code 4834.


