Footnotes :

1 - The City Planning Commission may hold the hearing itself or may direct the Director to hold the hearing.

2 - If the CPC recommends approval or disapproval initiated by the Director or the Council, the CPC shall transmit those actions to the Mayor for report to the Council. If CPC recommends disapproval initiated by itself, the CPC shall report its decision to the Council and Mayor.

3 - CPC receives recommendation from Director prior to making recommendation to Mayor.

4 - Hearing officer may be directed to hold the public hearing. If so directed, hearing and notification requirements are fulfilled by the public hearing conducted by the hearing officer.

5 - Process depicted demonstrates Application procedure

6 - If the matter was initiated by either the CPC or the Director, and the CPC recommends denial the decision is final. If the Planning Commission recommends disapproval of an application the applicant may appeal that decision to the City Council.

7 - If a hearing officer is designated to conduct the public hearing then the applicant, in addition to posting notice of the public hearing, shall also post notice of the initial Commission meeting

8 - If the Ordinance was proposed by initiation then the Commission shall act within 75 days. If the Planning Commission does not act by that deadline the Council may then request the Planning Commission to forward the matter for the Council’s action. If the Council does not do so, the time for the Planning Commission to act shall automatically be extended for an additional 75 days.

9 - APC shall hear and make recommendations, if the proposed zone or height district change results in < 50,000 gross SqFt floor area; < 50 dwelling units, ...etc.; or involving fewer than 65,000 square feet of lot area.
