Re: FY 2024 Dispute Resolution Program (Community)

Transmitted herewith for Mayor and City Council consideration is FY 2024 funding totaling \$149,653 to provide ongoing support for three Dispute Resolution Program (DRP) positions. This figure reflects a \$20,000 increase from FY 2023 from funding made available through the California Dispute Resolution Program Act. Funding passes through the County of Los Angeles Department of Consumer and Business Affairs to grantees awarded through a competitive process. This term represents the final year of a five-year grant award for the period July 1, 2023 through June 30, 2024.

Now in its 33rd year, DRP provides citywide mediation services as an alternative to formal administrative or court proceedings. During FY 2023, DRP serviced 400 initiated disputes and successfully mediated over 200 disputes, whereby both parties reached a mutually acceptable agreement. DRP also conducted community outreach to help build local capacity for individuals to informally resolve disputes, which included training of mediators and stakeholder groups.

1. AUTHORIZE the City Attorney, or designee, to:

 - b. Accept the grant award in the amount of \$149,653 from the County of Los Angeles Department of Consumer and Business Affairs;
 - c. Prepare Controller instructions for any necessary technical adjustments, subject to the approval of the City Administrative Officer and instruct the Controller to implement the instructions.
2. AUTHORIZE the Controller to:
 - a. Establish a receivable within Fund 368 in the amount of \$149,653 from the County of Los Angeles Department of Consumer and Business Affairs;
 - b. Establish a new appropriation account within Fund 368 as follows:
Account 12Y711 – DRP FY 2024 (Community) - \$149,653
 - c. Upon receipt of grant funds and approval of grant expenses, TRANSFER up to \$109,844 from Fund 368, Department 12, Account 12Y711 – DRP FY 2024 (Community) to Fund 100, Department 12, Account 001010 – Salaries General as reimbursement for City Attorney salary expenses of the two (2) resolution authorities;
 - d. Upon receipt of grant funds and approval of grant expenses, TRANSFER up to \$29,064 from Fund 368, Department 12, Account 12Y711 – DRP FY 2024 (Community) to Fund 100, Department 12, Revenue Source 5346 – Related Cost Reimbursement from Grants as reimbursement for City Attorney fringe benefits and indirect costs related to the DRP FY 2024 (Community).



The total cost of the DRP FY 2024 (Community) is \$187,067 of which \$149,653 will be reimbursed by the County of Los Angeles Department of Consumer and Business Affairs. The General fund contribution is \$37,414 in fringe and related costs (CAP 41) which are already included in the City Attorney adopted budget.

RECITALS

WHEREAS, reference is made to that certain document entitled “Office of the Los Angeles City Attorney Subaward Number DRP192009” executed on date June 28, 2019, (hereafter “Subaward”); and

WHEREAS, the parties hereto have previously entered into the above referenced Subaward for the purpose of providing Dispute Resolution Program (DRP) services as provided in California Business and Professions Code Sections 465-471.5; and

WHEREAS, the parties hereto have previously entered into the above referenced Subaward Amendment No. 1 to exercise the County's delegated authority to enter into the first option year, effective July 1, 2020 through June 30, 2021, and allocate Fiscal Year 2020-21 DRP funding; and

WHEREAS, the parties hereto have previously entered into the above referenced Subaward Amendment No. 2 to allocate \$15,000 in DRP funds to increase FY 2020-21 DRP funding allocation to cover Training cost and increase Information Technology resources; and

WHEREAS, the parties hereto have previously entered into the above referenced Subaward Amendment No. 3 to exercise the County's delegated authority to enter into the second option year, effective July 1, 2021 through June 30, 2022, and allocate Fiscal Year 2021-22 DRP funding; and

WHEREAS, the parties hereto have previously entered into the above referenced Subaward Amendment No. 4 to exercise the County's delegated authority to enter into the third option year, effective July 1, 2022 through June 30, 2023, and allocate Fiscal Year 2022-23 DRP funding; and

WHEREAS, it is the intent of the parties to enter into this Subaward Amendment No. 5 to exercise the County's delegated authority to enter into the fourth option year, effective July 1, 2023 through June 30, 2024, and to allocate Fiscal Year 2023-24 DRP funding as further described herein; and

WHEREAS, Subaward provides that further changes to its terms may be made in the form of a written Amendment, which is formally approved and executed by the parties.

NOW THEREFORE, the parties hereto agree as follows:

1. This Amendment shall commence upon execution by all parties.
2. Section 5.0, Subaward Sum, Subsection 5.1, Total Subaward Sum, Subsection 5.1.2, Funding Allocations, Subsection 5.1.2.1 is deleted in its entirety and replaced as follows:
 - 5.1.2.1 During the term of this Subaward, Subrecipient shall receive funding for providing the Services outlined in this Subaward. ("Subaward Sum" or "Maximum Subaward Sum"). The Maximum Subaward Sum for this Subaward is **\$742,677**, and broken out as follows:
 - FY 2019-20: \$149,653
 - FY 2020-21: \$164,653
 - FY 2021-22: \$149,653
 - FY 2022-23: \$129,065
 - FY 2023-24: **\$149,653**

3. Section 5.0, Subaward Sum, Subsection 5.1, Total Subaward Sum, Subsection 5.1.2, Funding Allocations, Subsection 5.1.2.8 is added as follows:

5.1.2.8 Subaward Sum Year 5 Funding Source(s)

5.1.2.8.1 The Subaward Sum Year 5 for this Subaward is comprised of monies which are identified by the funding source(s) or governing statute(s) listed below. The funding source(s) and governing statute(s) authorize County to use these monies to provide Program Services.

5.1.2.8.2 Dispute Resolution Program Act Year 5 funds available for use for contracted DRP Services: **\$149,653**

4. Section 10.0, Specific Work Requirements, Subsection 10.2, Community Dispute Resolution, Subsection 10.2.2, Minimum Cases Resolved, Subsection 10.2.2.3, Resolved Cases in Other Areas, of Exhibit A, Statement of Work, is deleted in its entirety and replaced as follows:

10.2.2.3 Resolved Cases in Other Areas

Beginning July 1, 2022 through June 30, 2024, Subrecipients shall be allowed to count a maximum of twenty (20) percent of Subrecipient's total Resolved Cases for cases resolved in which all parties to a dispute are outside of a Subrecipient's contracted area(s).

5. Section 10.0, Specific Work Requirements, Subsection 10.3, Civil Court Connected Dispute Resolution, Subsection 10.3.5, Resolved Cases in Other Areas, of Exhibit A, Statement of Work, is deleted in its entirety and replaced as follows:

10.3.5 Resolved Cases in Other Areas

Beginning July 1, 2022 through June 30, 2024, Subrecipients shall be allowed to count a maximum of twenty (20) percent of Subrecipient's total Resolved Cases for cases resolved in which all parties to a dispute are outside of a Subrecipient's contracted area(s).

6. Section 10.0, Specific Work Requirements, Subsection 10.4, Restorative Justice Dispute Resolution, Subsection 10.4.7, Resolved Cases in Other Areas, of Exhibit A, Statement of Work, is deleted in its entirety and replaced as follows:

10.4.7 Resolved Cases in Other Areas

Beginning July 1, 2022 through June 30, 2024, Subrecipients shall be allowed to count a maximum of twenty (20) percent of Subrecipient's total Resolved Cases for cases resolved in which all parties to a dispute are outside of a Subrecipient's contracted area(s).

7. Exhibit W, Budget, "Exhibit W-4, Budget FY 2023-2024," is added as an addendum to "Exhibit W, Budget," and is attached hereto and incorporated herein by reference.
8. Exhibit X, Mandated Program Requirements (MPS), "Exhibit X-4, MPS FY 2023-24," is added as an addendum to "Exhibit X, MPS," and is attached hereto and incorporated herein by reference.


All other terms and conditions of the Subaward shall remain in full force and effect.
