Neighborhood Council board members are volunteers and it would be helpful if they received confirmation that you received their CIS.

The CIS process was enabled by the to Los Angeles Administrative Code §Section 22.819. It provides that, "a Neighborhood Council may take a formal position on a matter by way of a Community Impact Statement (CIS) or written resolution." NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or resolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website. Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Council's rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

Summary: Palms Neighborhood Council supports Council File CF16-1104-S3 and encourages the City Council to also apply the same changes to Neighborhood Council meetings. In this politically divided time with raised tensions, the work of community government relies on civil discourse. One need only attend a Los Angeles City Council chamber meeting or a meeting of several targeted neighborhood councils throughout the City to experience how a handful of individuals are able to disrupt discussions for sport, viscously attacking community volunteers and elected officials with vile language and pointless hate speech. Transparency in government is crucial, and stakeholders must be allowed to criticize the work of

government without fear of reprisal. But this process is actually degraded and undermined when individuals with no productive aims destroy the public dialogue and engagement with hate speech targeted only at blowing up the process. The important work of the Neighborhood Council System and City Council is severely compromised when hate speech verbal abuse is protected and takes up valuable time that needs to be devoted to constructive dialogue.
