

ORDINANCE NO. _____

An ordinance amending Schedule “A” of Section 4.61 of the Los Angeles Administrative Code to update the salaries of certain non-represented classes paid on an hourly basis to conform to the Los Angeles Minimum Wage Ordinance (Ordinance No. 184320, as amended by Ordinance No. 187456), codified in Los Angeles Municipal Code Section 187.02D, and provide related salary adjustments. In addition, the previously eliminated positions of Gang Reduction and Youth Development (GRYD) Worker IV, V, and VI are hereby re-established.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. The following class positions in Schedule “A” of Section 4.61 of the Los Angeles Administrative Code are amended as follows:

0178-3	GRYD Worker III	\$22.00/hr.
0178-4	GRYD Worker IV	\$24.00/hr.
0178-5	GRYD Worker V	\$25.00/hr.
0178-6	GRYD Worker VI	\$26.00/hr.

Sec. 2. Section 1 shall be operative on July 1, 2025, December 28, 2025, and June 28, 2026.

Sec. 3. This ordinance shall be effective upon publication, pursuant to Charter Section 252(g).

Sec. 4. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
