



**DISCUSSION**

This donation will provide sustained financial support for the LAPD University. The LAPD University utilizes the Allogy platform which allows officers and civilians to complete training through the ease of computers and mobile devices, preventing the need to leave or change their primary duty for an entire shift to attend a course at a Department Training Facility. Since the LAPD University's inception through June 2024, students have completed over 40,450 training courses, amassing a total of over 242,000 training hours. The platform has played a pivotal role in ensuring that officers complete the hours and subjects of training mandated by the California Peace Officers Standards and Training (CA POST).

Approval of this donation will affirm the Department's commitment to the innovation, efficiency, and continuous improvement of law enforcement training practices. Below is a list of items to be donated, along with their estimated value.



OF LOS ANGELES POLICE DEPARTMENT UNIVERSITY

It is requested that Training Division be approved for funding in the amount of \$250,000 for the Los Angeles Police Department University (LAPDU). Approval of this grant benefits the Department as follows:

The purpose of this grant is to fund LAPDU, which has become an integral part of the Department by providing asynchronous training for officers and civilians through workstation computers, or by utilizing the LAPDU app and completing needed training via mobile device. LAPDU has allowed students to stay in the field, or at their regular place of duty while they complete needed training. LAPDU allows students to complete needed training for credit through California Peace Officers Standards and Training (CA POST). LAPDU allows training to be completed without the need to leave/change the students primary duty for the entirety of their shift to attend the course at a Department Training Facility.

Allogy is the company that provides LAPDU services to the Department. Allogy provides the platform and use of servers to offer courses that are engaging and specifically tuned to the needs of the Department. Allogy and their diverse team of engineers and instructional designers assist in the creation and utilization of cross platform and evidence-based learning techniques. The evidence-based techniques utilized by Allogy foster learner competency and lifelong learning with proven theoretical concept. Allogy utilizes blended learning which combines formal learning pathways with on-demand performance support while delivering standards-based content from trusted sources.

From LAPDU's inception through June 2024, over 40,450 training courses have been completed by officers and civilians, amassing a total of over 242,000 training hours. All courses are currently eligible for reimbursement through the collaborative efforts with the College of the Canyons and the Department's Revolving Training Fund, projecting an estimated reimbursement of \$509,682.60 since inception.

Six accredited online training courses are offered through LAPDU for credit with CA POST. The training courses offered facilitate professional development in key areas such as Use-of-Force/De-escalation, Implicit Bias, Leadership, Organizational Wellness, and Tactical Medicine. In addition, expansion plans include the development of "Mental Health Intervention Training

for Investigators". As we navigate the intricacies of sustaining this pivotal platform, it is imperative to underscore the necessity of continued financial support.

Inclusivity is fostered by LAPDU through providing open access to all Department personnel. This egalitarian approach ensures that every student has the opportunity to enhance their skills and knowledge base, reinforcing organizational cohesion and efficacy. LAPDU has also played a pivotal role in ensuring that officers complete the hours and subjects of training that are mandated by CA POST per California Senate Bill 230. Senate Bill 230 requires that regular and periodic training regarding Use-of-Force / De-escalation. LAPDU allows for students to receive Perishable Skills Program (PSP) and Continued Professional Training (CPT) credit to meet the mandates of Senate Bill 230.

Sustained financial support for LAPDU is not merely an investment in technology but a strategic imperative for the Department. By prioritizing grant funding for LAPDU, we affirm our commitment to innovation, efficiency, and the continuous improvement of law enforcement training practices.
