Neighborhood Council board members are volunteers and it would be helpful if they received confirmation that you received their CIS.

The CIS process was enabled by the to Los Angeles Administrative Code §Section 22.819. It provides that, "a Neighborhood Council may take a formal position on a matter by way of a Community Impact Statement (CIS) or written resolution." NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or rResolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website. Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Council's rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

Summary: The Silver Lake Neighborhood Council opposes the Mayor's proposed Fiscal Year 2025-26 budget unless amended. The Mayor's proposed Fiscal Year 2025-26 Budget includes a \$25,000 annual allocation for each Neighborhood Council, a \$7,000 reduction from the current amount of \$32,000. It also provides for the rollover of all unexpended funds from this fiscal year to the following one. Over 20 years ago, NCs were allocated \$50,000 annually with the ability to rollover up to \$100,000. Since then, due to cost-of-living increases and inflation, a dollar of purchasing power now requires \$1.76. If the NC budget of \$50,000 in 2003 kept pace with inflation, the annual budget in 2025 would be approximately \$87,000. The Silver Lake Neighborhood Council requests that the Mayor and City Council restore the

amount annually allocated to at least the current \$32,000. The SLNC also supports the rollover of all unexpended funds from this fiscal year to the next, as proposed in the Mayor's budget.
