Subject: RESOLUTION NO. 23-10191: FIRST AMENDMENT TO AGREEMENT NO. 2012 WITH  
SOUTHERN CALIFORNIA EDISON COMPANY

Pursuant to Section 373 of the City Charter and Section 10.5 of the Los Angeles Administrative Code; enclosed for your approval is Resolution No. 23-10191 authorizing "Amendment 23-2012-A" for the Reciprocal License with Southern California Edison Company (SCE), which extends the term by five years, for a total aggregate term of thirty years. Under proposed First Amendment 23-2012-A, the expiration date would change from April 30, 2023, to April 30, 2028. All other terms, conditions, and obligations would remain unchanged. There is no compensation payable by either the Harbor Department or SCE due to the reciprocal nature of the agreement. The Board of Harbor Commissioners approved and ratified the proposed first amendment at their meeting on June 7, 2023. There is no impact to the General Fund.

#### RECOMMENDATION FOR CITY COUNCIL:

1. ADOPT the determination by the Board of Harbor Commissioners that the proposed action is administratively exempt from the requirements of the California Environmental Quality Act (CEQA) in accordance with Article III Class 1(14) of the Los Angeles City CEQA Guidelines; and;
2. APPROVE Resolution No. 23-10191 for the proposed First Amendment to Reciprocal License Agreement No. 2012 between the City of Los Angeles Harbor Department and Southern California Edison Company;
