

Agenda Description: CATEGORICAL EXEMPTION, ENERGY, CLIMATE CHANGE, ENVIRONMENTAL JUSTICE, AND RIVER COMMITTEE REPORT, and ORDINANCES FIRST CONSIDERATION relative to an ordinance adding Article 5 to Chapter XIX of the Los Angeles Municipal Code (LAMC) to prohibit the distribution and sale of Expanded Polystyrene (EPS) products commonly referred to under the trade name Styrofoam; an ordinance adding Article 2.1 to Chapter XIX of the LAMC to promote the use of reusable bags and regulate the use of plastic and paper single-use carryout bags at apparel stores, farmers' markets, food or beverage facilities, hardware stores, and open air markets; and an ordinance adding a new Article 27 to Chapter 1, Division 10 of the LAMC relative to the reduction of single-use plastics, including reusable alternatives, zero-waste events, facilities, and related matters.
