REPORT RELATIVE TO PLUM COMMITTEE CONSIDERATION OF RESIDENT PROTECTIONS ORDINANCE AMENDMENTS TO THE AFFORDABLE HOUSING INCENTIVES GUIDELINES AND FAIR HOUSING REQUIREMENTS FOR AFFORDABLE HOUSING; CF 21-1230-S8; CASE NO. CPC-2024-388-CA; ENV-2020-6762-EIR; ENV-2020-6762-EIR-ADD1; ENV-2020-6762-EIR-ADD2

On September 26, 2024 the City Planning Commission recommended approval of the Resident Protections Ordinance without amendment. While the Resolution considered by CPC stated that it would be adopted by CPC, the CPC's action inadvertently resulted in a recommendation instead. Therefore, the amended resolution is being presented to the City Council for adoption (see Modified Exhibit B.1 - City Council Resolution, transmitted to the Council File on November 13, 2024).


Recommendation
