Research

Principal Investigator, The Philippine Support Movement in the United States, 1972-1991:
 This project has two components: First is a book project on the history of the Anti-Marcos Movement in the United States. The book will utilize oral histories of the many activists who were part of this movement as well as the enormous educational and propaganda literature that was produced during the period. The collection of these oral history tapes was started two years ago and will be continuing for some time. The second part is an archival project. This involves developing a collection of primary source materials from this movement which will eventually become part of UCLA Special Collections. Two major organizations have already donated materials to this growing collection: the Philippine Resource Center, which functioned as a clearinghouse for the movement, and the KDP, a lead movement organization during the period. The investigator's own personal collection of materials will also be added to the archive. (Ongoing)

Principal Investigator, Violence Prevention Among Asian American Youth: A focus on Filipino and Vietnamese Gangs. Research project funded by the California Wellness Foundation. (1998-2000)

Principal Investigator, Confrontations, Crossings, and Convergence: Photographs of the Philippines and the United States, 1898-1998. A photographic exhibition in commemoration of the centennial of Philippine-US relations. UCLA Fowler Museum, August 16, 1998-March 3, 1999. (A companion exhibition catalog with the same title has just been published, December, 1998)

Faculty Development and Recruitment:

At UCLA:

Coordinated the Center visits of all candidates for the various Asian American Studies faculty positions during 1991-1994; arranged for job talks specific to Asian American studies, individually met with each of the candidates during their campus visits to brief them on the Asian American Studies Center, the Asian American Studies program, and discuss with them their research and teaching interests in Asian American Studies. This responsibility also involved attending job talks in art history, comparative literature, economics, English, history, law, psychology, public health, sociology, and social welfare, and participating in Center level discussions of the candidates.

At CSUN:

As Department Chair, led the department in a recruitment effort that more than doubled the number of tenured/tenure track faculty of the department from 3 ½ to 8 ½ over the 3 year period of my term as Department Chair. In effect, over my 3 year term, we were able to successfully search for and recruit five (5) tenure track faculty, dramatically boosting the academic and program resources of the department.

Grantsmanship and Grant/Project Management:

Developed a variety of proposals for curriculum development and curriculum integration projects that would also subsidize the development and teaching of undergraduate courses in Asian American Studies. Funds obtained through these proposals provided funding that enabled the program to develop courses contributed to the diversity of its curriculum. Co-Investigator for Filipino American Literature project funded by California Council for the Humanities (1992). Developed the grant proposal for a research project on Asian American Youth Gangs which was funded by the California Wellness Foundation; this research project is currently ongoing.

As Chief Operating and Development Officer for Pacific Asian Consortium in Employment (PACE), primarily responsible for growth in agency budget from \$350,00 to over \$4.5 million in a ten year period from 1978 to 1988. Exercised direct oversight over implementation of funded programs resulting in the diversification of agency services from basic employment services to Headstart Preschool programs, energy conservation and weatherization programs, refugee resettlement services, home repair and rehabilitation services, and youth counseling programs.

Administrative:

Department Chair, Asian American Studies, California State University, Northridge. (2000-2004)

Assistant Director of the UCLA Asian American Studies Center. Exercised oversight over day to day operations of the Center. Key duties include chairing of Center Coordinating Committee meetings, coordination and participation in selection process for postdoctoral fellows, predoctoral fellows, and research grant awardees. In charge of developing annual schedule of faculty colloquia and center annual reports. As curriculum coordinator, supervised temporary faculty, scheduling of classes, student outreach and recruitment for the graduate program. Coordinated the admissions and fellowship selection process. Liaison responsibilities with other units of the university and with community based organizations.(1989-1999)

At PACE (Pacific Asian Consortium in Employment), functioned as **Chief Operating Officer** with direct oversight over all projects including hiring and supervision of project managers; developed organization's management policies and MIS to accommodate growth and expansion including responsibility computerization of the entire organization. Liaison responsibilities towards grantors, other community based organizations, and with City, County, State, and Federal government agencies. (1978-1989)

Community Service:

Administrative Consultant and Educational Programs Coordinator: Filipino American Service Group—Community Wellness Center; responsible for curriculum design and workshop leader for Healthy Tayo workshops as well as curriculum design of Healthy Active Lifestyle Program

Served in various boards and advisory panels of community based organizations, such as Immaculate Heart of Mary School, Search to Involve Pilipino Americans (SIPA), Leadership Education for Asian Pacifics (LEAP) Public Policy Institute, Filipino Civil Rights Advocates (FILCRA), and the Western Regional Board of the United Way; Additional service also in boards of foundations that fund community organizing projects such as the Funding Exchange (New York), and the Liberty Hill Foundation (Santa Monica, California). Also served in corporate advisory councils that assisted these corporations in adapting to company policies and procedures to a culturally diverse workforce and market, e.g., the Multicultural Issues Advisory Board of the Southern California Gas Company and the Southern California Diversity Task Force of Pacific Bell. President of the Board of Directors of Filipino American Service Group, Inc., a community based social service organization serving the Filipino Town /Temple Area in Los Angeles.

For the Academic community served as board member and later, President of APAHE (Asian Pacific Americans in Higher Education) a statewide professional association of Asian American faculty, staff and students in institutions of higher education in California.

Student Affairs:

Function as Graduate Adviser for the MA program in Asian American Studies, responsible for graduate student orientation, academic counseling, and periodic progress towards degree audits. Other responsibilities include supervision of Center based student counselors for undergraduates in the major.

Additionally, you will be required to attend public meetings at City Hall where your reappointment will be considered. You will be hearing from our office and a City Council Clerk who will let you know when your reappointment will be considered by the Civil Rights, Equity, Immigration, Aging, and Disability Committee. Sometime thereafter, you will be notified of the date when your reappointment will be presented to the full City Council. Immediately following the meeting, you will again be required to take the Oath of Office in the City Clerk's Office located in Room 395 of City Hall.
