

An altercation erupted and masses of people fled the location. A short time later, Quincy was discovered nearby the location suffering from a gunshot wound to the head and pronounced deceased. Quincy was a 16-year-old star athlete and scholar at Crenshaw High School. The detectives believe a reward may compel member of the public to provide information on the persons responsible for this crime.

The person or persons responsible for this crime represent an ongoing threat to the safety of the people of Los Angeles; therefore, it is appropriate for the City of Los Angeles to offer a reward for information leading to the identification, apprehension and conviction of the person or persons responsible for this crime.
