

ORDINANCE NO. _____

An ordinance amending Divisions 8 and 22 of the Los Angeles Administrative Code to remove references to the Greater Los Angeles Zoo Association, revise the structure of the Board of Zoo Commissioners, remove references to the Zoo Capital Program Oversight Committee and associated exhausted funding sources, and make other technical changes.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Chapter 25 of Division 8 of the Los Angeles Administrative Code is deleted in its entirety.

Sec. 2. Subsection (d) of Section 22.704 of Article 2, Chapter 27, Division 22 of the Los Angeles Administrative Code is amended to read as follows:

(d) No person shall be appointed or confirmed to serve on the Board who is a tenant, lessee, or operator of a concession on Zoo property.

Sec. 3. Section 22.705 of Article 2, Chapter 27, Division 22 of the Los Angeles Administrative Code is amended in its entirety to read as follows:

Sec. 22.705. Terms of Members of the Board.

The term of office for each member of the Board shall be for five years and shall begin with the first day of July of the respective years. Each appointment to fill a vacancy on the Board shall be for the period of the unexpired term of the incumbent.

Sec. 4. Section 22.712 of Article 2, Chapter 27, Division 22 of the Los Angeles Administrative Code is deleted in its entirety.

Sec. 5. Sections 22.715 and 22.716 of Article 4, Chapter 27, Division 22 of the Los Angeles Administrative Code are deleted in their entirety.


Sec. 6. Section 22.716.1 of Article 4, Chapter 27, Division 22 of the Los Angeles Administrative Code is renumbered to Section 22.715.

Sec. 7. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
