The CIS process was enabled by the to Los Angeles Administrative Code §Section 22.819. It provides that, "a Neighborhood Council may take a formal position on a matter by way of a Community Impact Statement (CIS) or written resolution." NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or rResolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website. Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Council's rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

COMMUNITY IMPACT STATEMENT

RE: Support for Council File Motion 25-0046

The Pico Union Neighborhood Council strongly supports Council File 25-0046, proposing a Bond measure for the June 2026 Elections to fund maintenance and upgrades for all Fire Stations in Los Angeles.

Our first responders need proper infrastructure to be deployed quickly during crises. Despite aging facilities, the Fire Department has seen a 55% increase in incident calls since 2010, responding to over half a million calls in 2023 alone.

In recent budget cycles, the Fire Department requested \$20 million annually for repairs but received only \$7.8 million in Fiscal Year 23/24 and no funding in Fiscal Year 24/25. The department operates 106 Fire Stations across nearly 470 square miles, with half of these stations over 50 years old.

We agree with the motion to urge the City Administrative Officer, Chief Legislative Analyst, City Attorney, and Los Angeles Fire Department to report with recommendations in 60 days on a proposed ballot measure for the June 2026 Election. This measure would fund maintenance and new construction, bringing the Fire Department up to modern standards.
