Honorable Members:

Transmitted herewith for your consideration are Resolutions requesting the Los Angeles County Board of Supervisors to authorize the consolidation of the special elections for four City of Los Angeles initiative measures with the State Primary Election, to be held on March 5, 2024. In conjunction with these proposed Resolutions, but under separate cover, the Office of the City Attorney has transmitted the Special Election Ordinances calling special elections to submit the initiative ordinances to the qualified voters of the City of Los Angeles.

These consolidation Resolutions must be submitted to the Los Angeles County Board of Supervisors as soon as possible after adoption in order to ensure that any applicable deadlines to make the consolidation request are met.

RECOMMENDATION

It is recommended that the City Council adopt the attached Resolutions requesting that the Los Angeles County Board of Supervisors authorize the consolidation of the Special Elections for four City of Los Angeles initiative measures with the State Primary Election to be held on March 5, 2024.

FISCAL IMPACT STATEMENT

For the March 5, 2024 Primary Nominating Election, there is approximately \$15.5 million in the current Fiscal Year (FY) 2023-24 budget for both the County of Los Angeles and City of Los Angeles election-related costs. The County of Los Angeles cost estimate of
