**Comments for Public Posting:** I am shocked and horrified to discover the possible loss of a green space in my neighborhood, that is, the removal of the little park (which some call "Slope Park") that marks a steep but pleasant climb from Effie Street at Maltman Avenue to Crestmont Avenue above it. I made this discovery on my most recent Sunday walk (8/28/22) when I saw posters at the park and on surrounding streets saying that the park is under threat of a "give away" to "private developers through a permanent STREET VACATION process." This feels so wrong to me. Do we really want yet another ugly box-like building to replace a small but pretty, tree-filled public space (yes, trees!)? In Silver Lake, we don't have that many neighborhood green spaces. Please let's keep what we have. This little park is akin to the historic stairway walks in our neighborhood. I live near the Descanso Steps and the Music Box Steps where I see tourists walking every weekend. The only difference is that "Slope Park" has steep sidewalks rather than steps. It is more of a pocket park along a stretch of Maltman that was never used as part of the street, perhaps because of its steep grade. Personally, this public green space means a lot to me. I have been walking through it for 22 years. I call it my "Sunset Walk," because it goes up the west side of the Micheltorena hill to the very top. Along the way, you can see almost all the way to the ocean. During this climb you can also, of course, watch the sun set. Just beyond the little park, you can see the Hollywood sign, the Griffith Park Observatory, and more. I have taken friends and family visiting from England and New York on this walk, which they always love. I discovered more about the threat to the park and some of its history from a blog online (link below) which makes the thought of its loss even more upsetting.
