

**ORDINANCE NO. \_\_\_\_\_**

An ordinance amending Subsection (a) of Section 4.203 of the Los Angeles Administrative Code, pertaining to Authorization for Certain Deductions, to add the recognized employee organizations of Actors' Equity Association, representing the classification of Observatory Lecturer in the Educational Presenters Unit, the American Federation of State, County and Municipal Employees, Local 741, AFL-CIO, representing the Recreation Assistant Unit, and the American Federation of State, County and Municipal Employees, Local 3672, AFL-CIO, representing the Executive Administrative Assistants Unit. The name of the recognized employee organization of Los Angeles Professional Managers' Unit is corrected to read Los Angeles Professional Managers' Association.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. The alphabetical listing of "Recognized Employee Organizations (Unions)" under Subsection (a) of the Los Angeles Administrative Code is amended to read as follows:

Sec. 2. Section 1 shall be operative upon publication.

Sec. 3. This ordinance shall be effective upon publication, pursuant to Charter Section 252(g).

Sec. 4. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
