Comments for Public Posting: Honorable Councilmembers and PLUM Committee Staff, On behalf of the Jewish Historical Society of Southern California, which works to preserve and create awareness of the rich history of the local Jewish community, I am writing about the historic B'nai B'rith Los Angeles Lodge building at 846 S. Union Avenue, Los Angeles. This building, designed by important architect S. Tilden Norton, who was himself a leading member of the Jewish community, is an architectural, cultural and historic landmark reflecting the layered history of Jewish organizational life, the labor and civil rights movements, including serving as the location where the Teamsters Union was integrated. We are grateful to the City Planning staff for refusing to grant a demolition permit, and note the absence of a plan for site that could readily incorporate and adaptively reuse this building. We urge the PLUM Committee to table any discussions of a proposed settlement between property owner Catholic Charities and the City Attorney until the agreement is made public as part of the writ of mandate proceedings, and to hold a public hearing regarding the potential demolition so that residents can participate.
