SUBJECT:

Temporary Closure of 121st Street between Figueroa Street and Hoover Street.

RECOMMENDATIONS:

- A. That the street as shown on the attached sketch, subject to the conditions contained herein, be temporarily closed pursuant to State Vehicle Code Section 21101.4 for a period of eighteen (18) months upon Council approval.
- B. That the City Council find that this is categorically exempt under Article III, Class 5, of the Los Angeles City Guidelines for the implementation of the California Environmental Quality Act of 1970.
- C. That the City Council adopt the accompanying Resolution signed by the City Attorney.
- D. That the City Council adopt the following findings:
 - 1. There is substantial evidence of serious and continual criminal activities in the street recommended for temporary closure.
 - 2. The temporary closure of the street will reduce the criminal activity in the area.
 - 3. The street does provide necessary vehicular or pedestrian access to adjacent properties but affected property owners have agreed to the temporary closure.

4. The closure will not substantially adversely affect traffic flow, safety on adjacent streets or in the surrounding neighborhoods, the operation of emergency vehicles, the performance of municipal or public utility services, or the delivery of freight by commercial vehicles in the street proposed to be temporarily closed.
 5. Vehicular and pedestrian traffic on the street contributes to the criminal activities.
 6. The street has not been designated as a through highway or arterial street.

FISCAL IMPACT STATEMENT:

The Bureau of Engineering is absorbing the cost of processing the request in the approximate amount of \$5,000.00. Maintenance of the public easement by City forces will be eliminated.

TRANSMITTALS:

1. Sketch indicating the area to be temporarily closed.
2. Petition.
3. Letter from Councilman Buscaino of Council District No. 15, dated February 5, 2013.
4. Letter from the Police Department, dated July 22, 2013.
5. Draft of Resolution for Temporary Street closure.

CONDITIONS:

1. That any gates to be installed to effectuate a physical closure of the street area together with the gate locations be approved by the Fire Department, and the Department of Water and Power and the Department of Transportation and the Bureau of Sanitation's Wastewater Collection Systems Division and be done under "B Permit" issued by the City Engineer and be installed at no cost to the City. Actual location of the gates will be specified at the time of "B-Permit" issuance.

2. The keys to any gates to be installed be provided to all affected City Departments and Public Utility Companies.
3. The routine clean-up of the closed area be provided by the adjoining property owners/residents.
4. That the closed area be physically closed within 6 months of Council approval of the temporary closure or the approval be rescinded.
5. That the petitioners agree to remove the gates/fences upon termination of the allowed closure period at no cost to the City.

DISCUSSION:

On February 5, 2013, a letter from Councilman Buscaino of Council District No. 15 was received directing the City Engineer to initiate proceedings to close 121st Street between Figueroa Street and Hoover Street. Councilman Buscaino's letter stated that, "The residents of this community have long endured criminal activity – including vandalism, litter, prostitution, and the sale of narcotics – which diminishes property values and negatively affects their quality of life."

Commanding Officer, Commander William Scott of Los Angeles Police Department in a letter dated July 22, 2013 stated "Sergeant Robin Petillo from Southwest Area, consulted with Senior Lead Officer Valdez, Serial No. 31265. The Los Angeles Police Department believes that the temporary closure would benefit public safety. The street has long been a location for prostitution and narcotic activity that has been a detriment to the area. Closure of 121st Street on Figueroa side would require residents to access the neighborhood from Hoover Street, but the benefit of crime deterrence would outweigh the inconvenience."

Conclusion:

The temporary closure of 121st Street between Figueroa Street and Hoover Street is feasible subject to the conditions of this report.
