Hello Chi, thanks for sending the appeals. I reviewed the first appeal by SAFER and even though they appealed the SPR entitlement, the appeal focuses on the SCEA and alleges that the SCEA is deficient, therefore, the SPR findings can not be made. The appeal attached a letter dated March 21, 2023 that our environmental consultant previously responded to. At this stage, I thought only the entitlements are before the City Council so let me know if we need to respond to the SAFER appeal.

With respect to the second appeal of the entitlements by Nam Kim, she provides no basis for her appeal. Her appeal justification makes brief statements regarding not enough affordable units but we are code compliant; regarding the setbacks at 8th and Harvard which are code compliant; not enough parking & she objects to replacing parking stalls with bicycle stalls but we are code compliant, regarding too many restaurants and bars in this community but no comments as to why approval of the MCUP would result in an over-concentration. I'm not sure her appeal merits a response but if you need me to submit something stating the lack of evidence to support her statements, I can submit something brief.
