
# LA Grand Exit Plan

Phase	Start Date	Description
Phase 1 (Active)	February 7	Focus on participants with existing linkages to HN, TLS, and Housing Vouchers
Phase 2	April 8	Focus on participants with no linkages to PH resources. Begin transferring participants to available IH sites.
Phase 3	May 1	Mayfair transfers begin: <ul style="list-style-type: none"><li>• 8 to 10 Transfers of DHS participants per day to Mayfair</li><li>• Mayor's Office Participants Transfer Begin</li></ul>

# Timeline


## January 2024: Demobilization Preparation

- **January 12, 2024:** LAHSA and Weingart kick-off meeting
- **January 30, 2024:** Demobilization kick-off



## February 2024: Active Demobilization


- **February 7, 2024:** Active demobilization begins (weekly meetings)
- **IMPORTANT NOTES:** Focus on transfers for those with a permanent housing resource (e.g. TLS)
