You are hereby notified that the Planning and Land Use Management (PLUM) Committee of the Los Angeles City Council will hold a public hearing in-person on **Tuesday, February 25, 2025** at approximately **2:00 P.M.**, or soon thereafter, in the John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, CA 90012 (entrance on Main Street), to consider the following: Categorical Exemption from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15303 Class 3, and related CEQA findings; report from the East Los Angeles Area Planning Commission (ELAAPC); and, an Appeal filed by Sarah Ramage, Frontenac Avenue Safety Coalition, from the ELAAPC's determination in approving a Categorical Exemption as the environmental clearance for the construction, use, and maintenance of a new two-story single family-dwelling measuring approximately 3,731 square feet with a 393 square foot covered garage on an 8,696.8 square foot vacant lot that is located within the Mount Washington-Glassell Park Specific Plan area; for the property located at 504 West Avenue 44.
