**AN ORDINANCE AMENDING DIVISIONS 8 AND 22 OF THE LOS ANGELES ADMINISTRATIVE CODE TO REMOVE REFERENCES TO THE GREATER LOS ANGELES ZOO ASSOCIATION, REVISE THE STRUCTURE OF THE BOARD OF ZOO COMMISSIONERS, REMOVE REFERENCES TO THE ZOO CAPITAL PROGRAM OVERSIGHT COMMITTEE AND ASSOCIATED EXHAUSTED FUNDING SOURCES, AND MAKE OTHER TECHNICAL CHANGES**

Honorable Members:

Pursuant to your request, this Office has prepared and now transmits for your consideration the enclosed draft ordinance, approved as to form and legality. The draft ordinance amends multiple sections in the Los Angeles Administrative Code to remove references to the Greater Los Angeles Zoo Association (GLAZA) and update the structure of the Board of Zoo Commissioners. The draft ordinance also removes obsolete references to the Zoo Capital Committee and associated exhausted funding sources.

Specifically, the draft ordinance amends Section 22.704(d) of Division 22, Chapter 27, Article 2 of the LAAC to remove the GLAZA representative as an ex officio member of the Board of Zoo Commissioners, and deletes Section 22.712 of Division 22,

Chapter 27, Article 2 of the LAAC and Section 22.716 of Division 22, Chapter 27, Article 4 of the LAAC to remove references to the City's contractual relationship with GLAZA. The draft ordinance also deletes Section 22.715 of Division 22, Chapter 27, Article 4 and Chapter 25 of Division 8 of the LAAC to remove references to the Zoo Capital Program Oversight Commission and associated funding sources that are now exhausted. Lastly, the draft ordinance amends Section 22.705 of Division 22, Chapter 27, Article 2 of the LAAC to remove now-obsolete references to the initial appointments of the Board of Zoo Commissioners members, and renumbers Section 22.716.1 of Division 22, Chapter 27, Article 4 of the LAAC to Section 22.715 due to the deletion of preceding subsections.
