Honorable Members:

On May 23, 2024, this Office transmitted Report No. R24-0273. The report inadvertently did not include the recommendation to amend contract C-138910, Stone Busailah. Therefore, we are transmitting this revised confidential report to include the recommendation.

Pursuant to California Government Code Section 54956.9(d)(1), the City Attorney's Office wishes to meet in closed session to discuss the need for additional funding and/or term extensions for the following outside counsel contracts, and puts forth the following Recommendations for the City Council's consideration:

1. Ask that the City Administrative Officer (CAO) identify funding in the amount of \$2,083,000 to accommodate the shortfall needed to fund all

current projections through June 2024 in outside counsel contracts listed in items #2 and #3 below and transfer this amount to Fund 100, Department No. 12, Account No. 009301 - Outside Counsel on the Year end Financial Status report;

2. Authorize the City Attorney to amend the following contracts to increase their respective authority amounts as follows:
