Before you attract additional negative attention to our fair City by encouraging a Mexican/Catholic organization to demolish a Jewish Synagogue, please read the attachment to this message and consider some alternatives.

I. Amend the LA Municipal Code

Amend Section 51.03, Article 16, Chapter IV of the Los Angeles Municipal Code to read as follows:

SEC. 51.03. DISCRIMINATION PROHIBITED

A. No person shall discriminate against another person in ~~private~~ employment, housing, education, government or commerce, because of that person's actual or perceived race, color, ethnicity, creed, age, national origin, religion, citizenship status, gender, gender identity or expression, sexual orientation, disability, medical condition, genetic information, lineage or casta/caste, marital status, source of income, military status, veteran status, or primary language.

II. Restore Haym Salomon Day to Los Angeles

Re-establish January 6 of each year as "Haym Salomon Day," by making Boyle Heights Jewish again, beginning with an annual patriotic parade through Boyle Heights and an interfaith commemorative ceremony in Hollenbeck Park.

An annual day of unity celebrating a Jewish-American Patriot would be a much better look than a destroyed Jewish synagogue in the heart of Los Angeles.

We are the Vice President and President of Save Beverly Fairfax, a 501(c)3 non profit corporation representing the Beverly Fairfax National Register Historic district. We ask our honorable councilmembers to vote no on item 3 of the PLUM agenda for Tuesday February 20th, Council File: 23-1407, Catholic Charities of Los Angeles, Inc. v. City of Los Angeles, or to table the item for further study.

The public has not been informed as to what is proposed in the agreement between Catholic Charities and the City, and we are concerned that whatever resolution the City has reached may include the demolition of the B'nai B'rith Lodge/AFL Teamster Hall building at 846 S. Union Avenue, an irreplaceable historical resource.

Along with its stunning Beaux Arts-style architecture, the building, like those in the Beverly Fairfax Historic District, tells the history of the Los Angeles Jewish community. In addition, it tells the history of the work of the Teamsters Union, and the struggles of African-Americans seeking to integrate the Union.

We urge you to read the building's complete history in the Historic Cultural Monument application, which was prohibited by Catholic Charities from being presented to the Cultural Heritage Commission in 2022: <https://bit.ly/SaveBnaiBrithBldg>.

Please vote no, and put a pause to any proposed demolition. There are ample opportunities for Catholic Charities of Los Angeles to implement adaptive reuse for their subsequent development, and we believe the public has the right to know and weigh in on any aspects of this settlement that may jeopardize this important historic resource.
