The Los Angeles City Council will hold a Public Hearing relative to an Ordinance amending Sections 22.117(d) and 22.117(i) of Article 3, Chapter 7, Division 22 of the Los Angeles Administrative Code (LAAC) to increase the admission fees for Hollyhock House and Watts Towers, and architectural design review fees.

The Los Angeles City Council will hold another Public Hearing relative to an Ordinance amending Sections 5.111.2 and 22.117(i) of the LAAC to allow the Department of Cultural Affairs to adjust its theater fees to reflect changes in revised labor rates.

The Public Hearing will be held on Tuesday, **December 10, 2024**, at **10:00 a.m.**, or as soon thereafter as the matter can be heard, in the John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, CA 90012.
