My research has been published in leading peer-reviewed scholarly journals such as *Urban Affairs Review*, *Sociological Perspectives*, *Race and Justice*, *PS: Political Science and Politics*, *Public Opinion Quarterly*, *National Civic Review* and various anthologies.

I build strong relationships within and across our member institutions, equipping our members with leadership and organizing skills and formulating strategies to act powerfully together on concrete issues facing our communities. Recent successes include expansion of rental assistance funds and tenant protections, neighborhood-based organizing strategies to promote access to Covid-19 vaccines in neighborhoods that had the highest rates of infection and mortality rates during the pandemic, and expansion of the California Earned Income Tax Credit for undocumented workers and their families – including advocacy that paved the way for an effective method of administering the Golden State Stimulus that sent funds directly to undocumented families who otherwise would not have had meaningful access. I previously spearheaded an initiative to align adult education curricula and workforce development with labor needs of local manufacturers.

I work closely with the Office of the U.S. Vice President on public events and communications. I have built lists of attendees for the Vice President's official (non-campaign) events, particularly when she travels to Los Angeles, and have participated in workshops at the White House. President, including young people and residents of some of Los Angeles's highest-poverty areas, who ordinarily would not have access to high-ranking public officials.

KIND provides *pro bono* legal representation for refugee and migrant children across the country. KIND has connected thousands of children and their caretakers with essential medical care, mental health care, educational opportunities, and crisis intervention to ensure their safety and well-being.

You are required to complete and return this form **within 21 days** of your nomination to the City Ethics Commission via the California Fair Political Practices Commission's eDisclosure website, or by mailing the forms to City Hall at 200 N. Spring Street, 24th Floor, Los Angeles, California 90012. Any inquiries regarding this form should be directed to Nicole Enriquez at the City Ethics Commission by email at nicole.enriquez@lacity.org.

Additionally, you will be required to attend public meetings at City Hall where your reappointment will be considered. You will be hearing from our office and a City Council Clerk who will let you know when your reappointment will be considered by the Civil Rights, Equity, Immigration, Aging, and Disability Committee. Sometime thereafter, you will be notified of the date when your reappointment will be presented to the full City Council. Immediately following the meeting, you will again be required to take the Oath of Office in the City Clerk's Office located in Room 395 of City Hall.
