I am still firmly against this project as this street and hillside can not be adequately supported through the construction of such a giant venture. There is no easy way for large trucks to even drive up our street as most can't make the zig-zag turn onto Glenridge drive, so maneuvering up the hill is difficult in any case. There is no safe turnaround for large trucks and a closed private drive at the top of the hill. My property has already sustained damage from multiple previous construction drivers trying to turn around at the top of the hill and/or having inexperienced drivers trying to turn around at the top. Additionally, the amount of dirt and earth that is required to be removed from the hillside destabilizes the entire hill and road. We are deeply concerned that this irresponsible project will not be sufficiently overseen on a day-to-day basis to give residents pass through as they undertake the massive creation of new roadway on the property and giant retaining walls that this project would require, destabilizing our entire street.. There is not enough space on our street for two cars to drive in opposite directions at the same time, let alone giant trucks carrying cement or earth. This project will likely cause major damage to the integrity of the hillside and Glenridge drive, disturb wildlife and create a massive headache for all residents for potentially years to come, causing us to be late for school or miss appointments because of backed up traffic and chaos on our narrow street with only one way in and out. Please consider the logistical nightmare and long term safety of all residents on our street. Thank you.

Have it be known all residents of Glenridge Dr. are against this project. The Project at 3701 Glenridge Dr has been fraught from the beginning. Time and time again this same grading project has been brought to the city where it is shut down by opposing neighbors for numerous ecological and safety reasons whereby the owners disband their LLC, open another with a new name and continue to try to get this project passed. I for one am exhausted explaining over and over for the past several YEARS why our street cannot sustain this kind of grading and I hope this will be the final time. The amount of dirt proposed to be excavated and removed is about 400 trucks worth. Our street is narrow and at times not even an amazon delivery person can get up and down with ease. Our mailbox has been smashed twice by delivery trucks trying to drop furniture. The amount of large trucks hauling this kind of dirt is simply not sustainable nor is it safe. How do these trucks turn around ? Are you aware there is no turn around on Glenridge Dr.? It becomes a private road at the top and does not connect to Mullholland from the north. These construction trucks would have to back up the street from the bottom. How would these trucks even make the turn from Weslin Ave. onto Glenridge Dr.? It is a hairpin turn that even a normal size pickup truck can barely make. Where is the parking for construction vehicles and workers? We often struggle to keep our streets clear for emergency vehicles, particularly during excessively windy conditions. There has been no consideration for the kind of wildlife this displacement will cause nor slope stability to the homes surrounding this project.

3701 Glenridge is part of a wildlife habitat zone/block. (Zone 11) and also on the Mulholland corridor.

All property owners adjacent would have to be named on their liability insurance at the tune of 20M each, is Glenridge Estate LLC prepared to do that?

The upper properties need to be insured for damage to their foundation due to grading and shoring activities.

I am requesting a third party review all submittals for Geology, Grading Slope stability and a sign off by the Mullholland Review Board.

They have done so without proper and legitimate permitting. They have been rejected by the Mulholland Review Board repeatedly. The owner of this property Glenridge Estate LLC is currently not a valid company in California. The property has been sold numerous times to obfuscate the unapproved actions taken to date. The original developer Sam Galston still continues to be on the project. There has been clear cutting and unapproved grading done on the property. There are 4 properties adjacent to the site, which are all subject to foundation failure if the owner does not properly grade and reinforce the site. The entrance will need significant build up to allow access for heavy machinery to the site. The Mulholland Scenic review board never approved plans for what was deemed to be a "super highway" with 20 foot tall caissons to support the access from the street to the back of the property where the house is to be built.

There is also an issue with drainage that could potentially be catastrophic for the homes on Benedict Canyon, below the project. I would like to know what mitigation efforts are going to be put in place in case a torrential storm washes out the property and floods the homes below.

As a representative of the neighborhood I would like to request a \$2,000,000 bond, up from the \$50,000, added for insurance purposes, given the track record of short-cuts that have been taken previously and the potential continued negligence of the developer to comply with city standards.

There have been several incidents over the years when one truck has tipped over at the turn onto Glenridge from Weslin and trapped residents above the turn and prevented access to the road by any vehicles below. My property is directly below the proposed development in Benedict Canyon. Benedict Canyon Drive currently acts as the only storm water drainage inside and in the slopes of the canyon, including the proposed construction site. Because the city has never provided adequate drainage (there is no underground drainage) while allowing additional development, the street acts as the drain. We have constant street level drainage of water collected around the entire canyon. This means there is standing water 365 days a year. This is both a health hazard (ie, vector issue) and a public safety issue (both pedestrians and vehicles has slipped). In addition, the condition of the pavement is constantly degrading. Any additional development in or around the canyon will exacerbate these problems. The permit under consideration should be disallowed until its effects on storm drainage are thoroughly evaluated.
