Comments for Public Posting: Hi, my name is Lin Ouyang, I am a tenant and I live in District 9. As a renter I want to strongly urge you to support the Right to Counsel Ordinance. No one should be ever evicted without a legal representation. I represented myself in court for about 10 years fighting for owed wages without any success. On top of that, I was convicted of misdemeanor and was put in jail by a civil court judge in the case filed myself as the plaintiff. Even worse, the court dismissed my appeal of the misdemeanor conviction stating I was not convicted of misdemeanor. Attached is the Commitment Order showing I was convicted of misdemeanor. As a renter, I have been facing unnotified inspections by the landlord, threats of illegal lockout. I was forced to move to an inadequate relocation unit. My experience tells me if I go to court in an eviction case without an attorney, I will be evicted even though I have valid defenses, just like my wages and hour lawsuit, the laws won't be followed when I don't have legal representations. Thus, I ask you to support the Right to Counsel Ordinance to make sure that the laws that protect tenants will be applied in court.

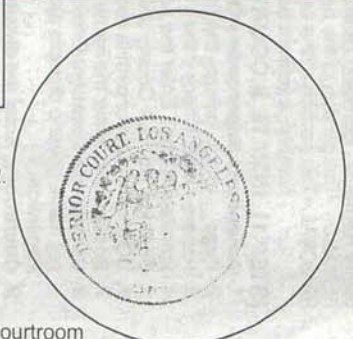
