## RECOMMENDATIONS

That the Mayor:

1. Approve Los Angeles World Airports Board Resolution No. 27822 authorizing a proposed Third Amendment to Contract No. DA-5249 with Telos Identity Management Solutions, LLC to continue providing Certified Designated Aviation Channeling Services at Los Angeles International Airport for an additional year from January 3, 2024 through January 2, 2025, with a one-year renewal option through January 2, 2026, with no additional funding authority;
2. Adopt the determination of the Board of Airport Commissioners that this action is exempt from the California Environmental Quality Act (CEQA) pursuant to Article II Section 2(f) of the Los Angeles City CEQA Guidelines; and
3. Authorize the Los Angeles World Airports Interim Chief Executive Officer, or designee, to execute the proposed amendment and return the Resolution documents to the Los Angeles World Airports for further processing, including Council consideration.

## SUMMARY

The Los Angeles World Airports (LAWA, Department) Board of Airport Commissioners (Board) requests approval of a proposed Third Amendment to Contract No. DA-5249 between the Los Angeles World Airports and Telos Identity Management Solutions, LLC (Telos) to extend the term of the agreement by one year from January 3, 2024 through January 2, 2025 with an option to extend the term by one additional year through January 2, 2026.

The proposed amendment will extend the current competitively bid contract with Telos for the processing, transmission, storage, and Management of Federal Bureau of Investigation (FBI) fingerprint-based initial criminal history records, subsequent FBI Records of Arrest and Prosecution

Background (RAP Back) notification records and security threat assessment records, in compliance with Transportation Security (TSA) mandates to utilize Designated Aviation Channeling (DAC) services. DAC services enable submissions of workers' biographic and biometric data to conduct background checks required of individuals working in secure areas of U.S. commercial airports.

The amendment to the existing agreement with Telos is necessary to maintain continuity of fingerprinting and badging operations as LAWA determines the next steps in either the upgrade or replacement of the current LAWA Credentialing System (CS). No increase in funding authority is required to finance the proposed amendment.

The proposed amendment has been approved as to form by the City Attorney. Pursuant to Charter Section 373 and Administrative Code Section 10.5, Council approval is required because the cumulative contract term exceeds three years. Our office has reviewed the request and recommends approval.

## **BACKGROUND**

*Original Agreement* - On November 2, 2017, the Board authorized execution of a three-year contract with Telos for DAC Services for the Airport Police Division and Security Credentials Section at Los Angeles International Airport (LAX) for an amount not-to-exceed \$3,137,655 (DA-5249). The term of the original contract commenced on January 3, 2018, and was scheduled to terminate on January 2, 2021, unless otherwise terminated as allowed for as specified in the contract.

*First Amendment* - On November 19, 2020, the Board approved the First Amendment to the Telos agreement extending the contract through January 2, 2022 with a one-year renewal option. The Department indicates that the amendment was required to maintain compliance with TSA regulations and security directives while LAX proceeded with the transition from the existing CS to the new Information Management and Credentialing System (IMCS) under development and implementation by Convergent Technologies, LLC (Convergent). The amendment also provided time for the Request for Proposal process to proceed for a new DAC contractor to replace Telos.

*Second Amendment* - On December 1, 2022 the Board approved a Second Amendment to the Telos agreement with a one-year renewal option to continue compliance with TSA regulations and security directives in support of the transition to the new IMCS. The change did not require additional funding.

*Continuity of IMCS & DAC Services / Request for Proposals* - While the LAWA Information Technology and Management Group (ITMG) awarded the Convergent contract in February 2019 with the intent to implement the IMCS by October 21, 2021, after several delayed go-live dates and a contract extension, Convergent failed to pass system tests to resolve functionality issues. Rather than continue with the project, ITMG chose to terminate the contract with Convergent on September 5, 2023, concurrent with the contract expiration date.

In recognition of the impending expiration of the Telos contract, LAWA initiated the Request for Proposals process to obtain a new DAC service provider. The American Association of Airport

Employees dba Transportation Security Clearinghouse (TSC) was selected as the new provider. Once the contract with Converjint was terminated, LAWA determined that the best course of action was to continue contracting with Telos for essential DAC services until a contract with TSC is finalized. The Department indicates that the contract with TSC and the integration with the current LAWA CS program should occur before the end of the 2024 fiscal year.

*Contract Costs* - The existing not-to-exceed contract authority for the Telos agreement is \$3,137,655. The Department indicates that expenditures on the contract to-date have been \$1,930,049, with unexpended contract authority of \$1,207,606 remaining. The availability of the remaining contract authority is the direct result of reduced costs related to the labor shortages experienced throughout the airport community. The proposed amendment therefore extends the term without a need for an increase in the contract authority.

Funds for the contract amendment are available in the Fiscal Year 2023-2024 Los Angeles World Airports Operating Budget in LAX Cost Center 1160022 – Security Credentials Section, Commitment Item 520 – Contractual Services. Funding for subsequent years will be requested as part of the annual budget process.

## **CITY COMPLIANCE**

*Small Business Enterprise (SBE), Local Business Enterprise (LBE), Local/Small Business Enterprise (LSBE) or Disabled Veterans Business Enterprise (DVBE) Participation* – The Department indicates that no mandatory SBE, LBE, LSBE or DVBE goals were established for this contract since no subcontracting opportunities were identified (File No. 10042636).

*Charter Section 1022* – Pursuant to Charter Section 1022, the Department has determined that the work specified in the proposed amendment can be performed more feasibly or economically by an independent contractor than by City employees.

*California Environmental Quality Act (CEQA)* – The Department has determined that as a continuing administrative, maintenance and personnel-related activity, approval of the proposed amendment is exempt from California Environmental Quality Act requirements pursuant to Article II, Section 2(f) of the Los Angeles City CEQA Guidelines.

The proposed amendment includes provisions to ensure compliance with applicable City ordinances, contracting, and insurance requirements. The City Attorney has reviewed and approved the proposed amendment. In accordance with Charter Section 373 and Administrative Code Section 10.5, the proposed amendment requires Council approval because the total term of the Agreement exceeds three years. Our Office recommends approval.

## **FISCAL IMPACT STATEMENT**

The existing not-to-exceed authority for Contract No. DA-5249 between the Los Angeles World Airports and Telos Identity Management Solutions, LLC is \$3,137,655. Funds for the amendment are available in the Fiscal Year 2023-2024 Los Angeles World Airports Operating Budget in LAX Cost Center 1160022 – Security Credentials Section, Commitment Item 520 – Contractual

Services. Funding for subsequent years will be requested as part of the annual budget process. The recommendations in this report comply with the Los Angeles World Airports' Financial Policies. Approval of the proposed amendment will have no impact on the City's General Fund.

RESOLUTION NO. 27822

WHEREAS, on recommendation of Management, there was presented for approval, Third Amendment to Contract DA-5249 with Telos Identity Management Solutions, LLC to extend the term through January 2, 2025, with a one (1)-year renewal option, covering certified designated aviation channeling services for Los Angeles World Airports; and

WHEREAS, the Transportation Security Administration (TSA) regulations and security directives require Los Angeles World Airports (LAWA) to process fingerprint-based Criminal History Record Checks and Security Threat Assessments, and to subscribe to TSA's Federal Bureau of Investigation (FBI) Record of Arrest and Prosecution Background (RAP Back) services through a TSA-certified designated aviation channeling (DAC) service provider. RAP Back is a service that employers can use to continuously monitor their employees' criminal and arrest records by receiving alerts from the FBI if there are any additions to an employee's FBI records; and

WHEREAS, in February 2019, a contract was awarded to Convergent to implement the LAWA Information Management and Credentialing System (IMCS) by October 21, 2020. However, after several delayed go-live dates and a contract extension, Convergent failed to pass system tests and resolve functionality issues. Rather than continue with the project, LAWA chose to terminate the contract with Convergent on September 5, 2023, in tandem with the contract expiration date; and

WHEREAS, the Third Amendment to the contract with Telos Identity Management Solutions, LLC (Telos) is necessary to maintain continuity of fingerprinting and badging operations as LAWA determines the next steps regarding either the upgrade or replacement of the current LAWA Credentialing System (CS), as LAWA has chosen not to move forward with the implementation of the IMCS; and

WHEREAS, in preparation for the expiration of the Telos's contract, in March 2021, the Request for Proposals process was completed for obtaining a DAC service provider, and the American Association of Airport Employees dba Transportation Security Clearinghouse (TSC) was selected as the new provider. While a new provider has been vetted and selected, it was recommended that DAC services continue with Telos until the IMCS was implemented, as the program was designed to integrate directly with Telos, and until the contract with TSC is finalized. It is anticipated that the contract with TSC and the integration of the system with the current LAWA CS program will take place before the end of fiscal year 2024; and

WHEREAS, the Third Amendment will allow the LAWA Security Badge Office, Security Credentials Section, to remain compliant with the TSA's regulations pursuant to the Code of Federal Regulations Title 49, Part 1542, as staff conduct background checks on all airport workers that require access to secure or restricted areas; and

WHEREAS, funds for the contract are available in the Fiscal Year 2023-2024 LAWA Operating Budget in LAX Cost Center 1160022 – Security Credentials Section, Commitment Item 520 – Contractual Services. Funding for subsequent years will be requested as part of the annual budget process; and

WHEREAS, this item, as a continuing administrative, maintenance and personnel-related activity, is exempt from California Environmental Quality Act (CEQA) requirements pursuant to Article II, Section 2.f of the Los Angeles City CEQA Guidelines; and



WHEREAS, Telos will comply with the provisions of the Living Wage/Worker Retention Ordinances, Affirmative Action Program, Child Support Obligations Ordinance, and Iran Contracting Act; and

WHEREAS, Telos is assigned Business Tax Registration Certificate 0003017783-0001-0; and

WHEREAS, Telos has approved insurance documents, in terms and amounts required, on file with LAWA; and

WHEREAS, pursuant to Charter Section 1022, staff determined that the work specified on the contract can be performed more feasibly or economically by an Independent Contractor than by City employees; and

WHEREAS, Telos has submitted the Contractor Responsibility Program Questionnaire and Pledge of Compliance, and will comply with the provisions of said program; and

WHEREAS, Telos has been determined by Public Works, Office of Contract Compliance to be in full compliance with the provisions of the Equal Benefits Ordinance; and

WHEREAS, Telos will comply with the provisions of the First Source Hiring Program for all non-trade Los Angeles International Airport jobs; and

WHEREAS, Telos has submitted the Bidder Contributions CEC Form 55 and the Municipal Lobbying Ordinance CEC Form 50, and will comply with their provisions; and

WHEREAS, actions taken on this item by the Board of Airport Commissioners will become final pursuant to the provisions of Los Angeles City Charter Section 373;

NOW, THEREFORE, BE IT RESOLVED that the Board of Airport Commissioners adopted the Staff Report; determined that this action is exempt from the California Environmental Quality Act (CEQA) pursuant to Article II, Section 2.f of the Los Angeles City CEQA Guidelines; approved the Third Amendment to Contract DA-5249 with Telos Identity Management Solutions, LLC to extend the term through January 2, 2025, with a one (1)-year renewal option, covering certified designated aviation channeling services for Los Angeles World Airports; and authorized the Interim Chief Executive Officer, or designee, to execute said Third Amendment to Contract DA-5249 with Telos Identity Management Solutions, LLC after approval by the Los Angeles City Council and approval as to form by the City Attorney.

**RECITALS**

WHEREAS, City and Contractor entered into a contract (hereinafter referred to as "Contract") dated November 29, 2017, for live, real time customer service, detailed account management, and technical and operational support for background checks on all airport workers at LAWA for the Department and as amended; and,

WHEREAS, the parties hereto desire to amend this Contract.

NOW, THEREFORE, in consideration of the covenants and conditions hereinafter contained to be kept and performed by the respective parties hereto, IT IS MUTUALLY AGREED that the Contract BE AMENDED AS FOLLOWS:

**AMENDMENT**

**Section 1.0** Subsection 1.1 of Section 1.0, Term of Contract, is deleted in its entirety and replaced with the following:

"The term of the Contract shall be for a period commencing on January 3, 2018, and shall terminate on January 2, 2025, unless otherwise terminated as set forth in this Contract."

**Section 2.0** Subsection 2.1 of Section 2.0 Incorporation by Reference, is hereby amended to include the attached revised pricing via quote number 092620231 issued to the City September 26, 2023, for period effective January 3, 2024, through January 2, 2025. Any conflict between this Contract and the attached pricing quote number 092620231 shall be resolved in favor of this Contract."

**Section 3.0** It is understood and agreed by and between the parties hereto that, except as specifically provided herein, this Third Amendment to Contract DA-5249 shall not in any manner alter, change, modify, or affect any of the rights, privileges, duties or obligations of either of the



parties hereto under or by reason of the said Contract DA-5249 and except as expressly amended herein, all terms, covenants, and conditions of the Contract DA-5249 and all amendments thereto, shall remain in full force and effect.

### SUBJECT

Request for approval of a Third Amendment to Contract DA-5249 with Telos Identity Management Solutions, LLC, to extend the contract term by one year through January 2, 2025, with a one-year renewal option through January 2, 2026, with no additional funding authority, to continue providing certified Designated Aviation Channeling services to Los Angeles World Airports.

### RECOMMENDATIONS

Management RECOMMENDS that the Board of Airport Commissioners:

1. ADOPT the Staff Report.
2. DETERMINE that this action is exempt from the California Environmental Quality Act (CEQA) pursuant to Article II, Section 2.f of the Los Angeles City CEQA Guidelines.
3. APPROVE the Third Amendment to Contract DA-5249 with Telos Identity Management Solutions, LLC, extending the contract for one year ending on January 2, 2025, with a one-year renewal option through January 2, 2026, with no additional funding authority.
4. AUTHORIZE the Interim Chief Executive Officer, or designee, to execute the Third Amendment after approval by the Los Angeles City Council and approval as to form by the City Attorney.

## DISCUSSION

### 1. Purpose

The purpose of the requested action is to extend the current contract with Telos Management Solutions, LLC (Telos) through January 2, 2025, for processing, transmission, storage, and management of FBI fingerprint-based initial criminal history records, subsequent FBI Record of Arrest and Prosecution Background (RAP Back) notification records, and security threat assessment records, in compliance with the Transportation Security Administration (TSA) mandates to utilize Designated Aviation Channeling (DAC) services.

### 2. Prior Related Actions/History of Board Actions

- **October 21, 2004 – Resolution No. 22509 (DA-3988)**  
The Board of Airport Commissioners (Board) approved authorization for the Executive Director to execute a 10-year City of Los Angeles contract with the American Association of Airport Executives (dba Transportation Security Clearinghouse) for background clearance services and replenishment of the revolving working capital account to be maintained at not less than \$200,000 through periodic reimbursements based on statements of actual expenses incurred.
- **December 10, 2014 – Resolution No. 25520 (DA-4940)**  
The Board approved authorization for the Executive Director to execute a two-year City of Los Angeles contract with TSC for background clearance services and replenishment of the revolving working capital account to be maintained at no less than \$200,000 through periodic reimbursements based on statements of actual expenses incurred.
- **November 2, 2017 – Resolution No. 26365 (DA-5249)**  
The Board approved authorization for the Chief Executive Officer to execute a three-year City of Los Angeles contract with Telos Identity Management Solutions, LLC for Designated Aviation Channeling Services for the Airport Police Division and Security Credentials Section, for an amount not to exceed \$3,137,655 at Los Angeles International Airport.
- **November 19, 2020 – Resolution No. 27135 (DA-5249)**  
The Board approved a contract extension through January 2, 2022, with a one-year renewal option, to maintain compliance with TSA regulations and security directives while Los Angeles International Airport undergoes transition from the current Credentialing System to the new Information Management and Credentialing System, as well as a Request for Proposals (RFP) process to evaluate and process Designated Aviation Channeling Services providers.
- **December 1, 2022 – Resolution No. 27634 (DA-5249B)**  
The Board approved a contract extension through January 2, 2024, with a one-year renewal option, to maintain compliance with TSA regulations and security directives while Los Angeles International Airport undergoes transition from the current Credentialing System to the new Information Management and Credentialing System.

### 3. Current Action/Rationale

The Transportation Security Administration's regulations and security directives require the Los Angeles World Airports (LAWA) to process fingerprint-based Criminal History Record Checks and Security Threat Assessments, and to subscribe to the TSA's FBI RAP Back services through a TSA-certified DAC service provider. RAP Back is a service that employers can use to continuously monitor their employees' criminal and arrest records by receiving alerts from the FBI if there are any additions to an employee's FBI records. The current contracted DAC services provider, Telos, is operating on an extension to a three-year contract that will expire on January 2, 2024.

An additional contract extension with Telos is necessary to maintain continuity of fingerprinting and badging operations as LAWA determines the next steps regarding either the upgrade or replacement of the current LAWA Credentialing System (CS), as LAWA has chosen not to move forward with the implementation of the LAWA Information Management and Credentialing System (IMCS).

In February 2019, LAWA Information Technology and Management Group (ITMG) awarded a contract to Convergent to implement the IMCS by October 21, 2020; however, after several delayed go-live dates and a contract extension, Convergent failed to pass system tests and resolve functionality issues. Rather than continue with the project, LAWA ITMG chose to terminate the contract with Convergent on September 5, 2023, in tandem with the contract expiration date.

In preparation for the expiration of the Telos contract, in March 2021, the Request for Proposals process was completed for obtaining a DAC service provider, and the American Association of Airport Employees (dba Transportation Security Clearinghouse (TSC)) was selected as the new provider. While a new provider has been vetted and selected, it was recommended that DAC services continue with Telos until the IMCS was implemented as the program was designed to integrate directly with Telos. Once the contract with Convergent was terminated, it was recommended that we continue with Telos for DAC services until the contract with TSC is finalized. It is anticipated that the contract with TSC and the integration of the system with the current LAWA CS program will take place before the end of fiscal year 2024.

With no finalized contract with TSC in place, it is prudent to extend the current Telos contract to guarantee continuous DAC services, allowing the Security Credentials Section to remain compliant with the TSA's regulations pursuant to the Code of Federal Regulations (CFR) Title 49, Part 1542, as staff conduct background checks on all airport workers that require access to secure or restricted areas. This is essential to allow the Security Badge Office staff to issue security credentials to new and current badge applicants who require fingerprinting and badging (LAWA has on average 52,000 such credential holders). Staff requests that the Board authorize the Interim Chief Executive Officer, or designee, to execute the Third Amendment to Contract DA-5249 with Telos, to extend the existing contract beyond the current expiration date of January 2, 2024, by one year, with a new expiration date of January 2, 2025. This extension will operate under the same terms and conditions as the current contract, with an additional one-year renewal option, utilizing the current funding authority.



Expenditures on the contract to-date are \$1,930,049, with a remaining contract authority of \$1,207,606. The following reflects the budget versus expenditures for the life of the contract with Telos. The overall trend of reduced costs is directly associated with labor shortages experienced throughout the entire airport community, along with the reduction in flights and passenger volume related to the COVID-19 pandemic.

There is no expected increase in rates for fingerprint-related services by Telos that would cause the Security Credentials Section to exceed the contract authority during the contract term extension.

#### ***How This Action Advances a Specific Strategic Plan Goal and Objective***

This action advances this strategic goal and objective: Ensure Safety and Security for Guests and Employees: Mitigate security threats. The proposed contract extension will allow for continuity of fingerprint and badging services for all aviation workers through the mandated FBI-based fingerprinting, utilizing the services of a TSA-certified DAC to transmit and manage the Criminal History Record Checks, Security Threat Assessments, and TSA's FBI RAP Back program for all aviation workers requiring such services as LAWA transitions to the new LAWA IMCS and subsequent enrollment in the U.S. Customs and Border Protection E-Badge Program. The goal and objective are to optimize an effective and efficient badging operation for LAWA stakeholders and provide the highest level of security for LAWA, airport employees, and the general public.

#### **4. Selection Process**

The current contract with Telos was awarded through a competitive process.

#### **5. Fiscal Impact**

Approval of the proposed action will not result in any additional fiscal impact to LAWA. The proposed amendment merely extends the term of the contract without further increases to the contract authority amount.

#### **6. Alternatives Considered**

- **None.**  
No alternatives were considered as it is imperative that LAWA have a contract with a

Designated Aviation Channeling service provider to comply with TSA security regulations. These services must be maintained without interruption.

## **APPROPRIATIONS**

Funds for this contract are available in the Fiscal Year 2023-2024 Los Angeles World Airports Operating Budget in LAX Cost Center 1160022 – Security Credentials Section, Commitment Item 520 – Contractual Services. Funding for subsequent years will be requested as part of the annual budget process.
