Re: 25-4118-S5

Pursuant to §41.18(c) of the Los Angeles Municipal Code, the following locations have been identified as areas where the continued sitting, sleeping, lying, storing of personal property, or otherwise obstructing the public right-of-way creates barriers to safe access and public use of these spaces.

The following locations have experienced serious public safety issues, as documented by either the Los Angeles Police Department, or the Los Angeles Fire Department, or both over a 13-month period beginning in March 2024 - April 2025:

Robertson Boulevard and the 10 Freeway, 90035

(8) incidents reported by LAPD involving burglary, vandalism, and motor vehicle theft.
(17) incidents reported by the LAFD involving rubbish fires.

Pico Boulevard and Camden Avenue, 90064

(7) incidents reported by LAPD involving trespassing, burglary, unlawful possession of drug paraphernalia, and theft.

676 S. San Vicente Boulevard, 90036

(5) incidents reported by the LAPD involving trespassing and disturbing the peace. (1) incident reported by LAFD involving a fire that also damaged the facade of an adjacent vacant building.

1400 Westwood Boulevard, 90024

(6) incidents reported by the LAPD involving battery, larceny, criminal threats, and vandalism. (16) incidents reported by the LAFD involving rubbish fires.

Burton Way at Robertson Boulevard, 90048

(1) Incident reported by LAFD involving an encampment fire in the area.

Holt Avenue at Burton Way, 90048

(5) incidents reported by the LAPD involving disturbing the peace and trespassing activity.

South Saint Andrews Place at Olympic Boulevard, 90019

(7) incidents reported by the LAPD involving theft, burglary and theft.

South Gramercy Place at San Marino Street, 90019

(5) incidents reported by the LAPD involving assault, theft, and burglary.

Pontius Avenue at Nebraska Avenue, 90025

(11) incidents reported by the LAPD involving threats, assault, weapons, and drug use.

The identified locations include an interim housing facility located on **2346 Cotner Avenue, Los Angeles, CA 90064**, which must remain available for individuals transitioning out of homelessness and the services that support them, while also maintaining stability for the surrounding community.

Outreach teams have previously conducted engagement at these sites, and in some cases, individuals who had been living in encampments have already been connected to housing, including interim housing and motel placements secured through coordination with the Mayor's Office, service providers, and the Los Angeles Homeless Services Authority (LAHSA). Housing has been identified for the individuals currently living at these locations as of the date of this letter. This resolution is being introduced to maintain safe access to these sensitive public spaces and prevent the return of encampments.

To ensure these locations remain accessible, functional, and safe for their intended use, a designating resolution is required for this location to be effective for a period of one year.
