We are deeply concerned about the potential consequences of these closures, not only for the individuals being processed through the City's jails, but for the safety and efficiency of our broader public systems. On-site medical care is an essential component of a humane and functional detention system. The proposed suspension would remove immediate access to care for detainees—many of whom arrive with preexisting conditions or in crisis—and instead shift the burden onto an already overwhelmed Metro Detention Facility. This risks delaying care, increasing transportation demands, and diverting law enforcement officers from patrol duties, ultimately compromising public safety. Furthermore, any decision of this magnitude must be made with full transparency and a clear understanding of its implications. We commend the motion's directive to require a 30-day report assessing health, staffing, cost, and operational impacts. We believe this is a necessary and prudent step to ensure the City's actions are informed by both data and the lived realities of our frontline workers. We urge the Committee and the full Council to adopt this motion and keep equity, safety, and responsibility at the center of any decisions regarding medical services in our detention facilities.
