Comments for Public Posting: Dear Housing and Homelessness Committee, I hope this letter finds you well. Public hearings on housing issues would also provide a platform for tenants to share their experiences and voice suggestions for improvements to the ordinance. Data collection and research initiatives will offer valuable insights into eviction rates, the demographics of affected tenants, and the broader impacts of displacement. Using this data to create compelling case studies that document unjust evictions can serve as a powerful advocacy tool. Additionally, I recommend implementing enhanced enforcement mechanisms. Increasing penalties for

landlords who evict without just cause or retaliate against tenants, coupled with establishing a monitoring and reporting system—possibly a hotline or online platform—will hold violators accountable. Access to legal aid and support services must be expanded to assist tenants facing the threat of eviction. Supporting initiatives for free or low-cost legal services is essential, as is promoting mediation programs that can help resolve disputes before they escalate to eviction. Finally, a public campaign utilizing social media and local media outlets could raise awareness about the Just Cause for Eviction Ordinance and mobilize tenants in support of its strengthening. Organizing tenant actions, such as rallies and petitions, would demonstrate overwhelming community support for stronger protections. By pursuing these strategies, we can work together to fortify the Just Cause for Eviction Ordinance, ensuring it effectively serves to protect tenants and promote housing stability in our city.
