(JULY THROUGH SEPTEMBER 2023)

RECOMMENDED ACTIONS

1. That the Board of Police Commissioners (Board) REVIEW and APPROVE the attached Supplemental Police Account (SPA) Third Quarterly Report.
2. That the Board TRANSMIT this report to the City Council and to the Office of the City Controller to comply with the provisions of Chapter 120, Section 5.520 of the Los Angeles Administrative Code.

DISCUSSION

Attached is a statistical recapitulation of Information/Contraband line item expenditures under the miscellaneous operational expenses category showing 27 SPA expenditures in which drugs or assets were seized, Attachment No. 1. These expenditures resulted in 49 arrests and the seizure of \$55,248.00 in United States currency. In addition, 212,655.27 grams of narcotics were seized. Any seized or forfeited property that was placed into service by the Los Angeles Police Department during this quarter will appear on this attachment. Attachment No. 2 is a year-to-date comparison of SPA seizures for the last five years. Attachment No. 3 is a report from Fiscal Group detailing expenses incurred from the Council-approved expenditure plan by the appropriation account.
