Comments for Public Posting: This is an urgent issue that we desperately need to fix. The current process to permit covered outdoor dining, via the LA Al Fresco Program, has proved practically impossible. Many members of the Los Angeles restaurant community have voiced their concerns about this issue. It has prevented many of us from submitting an initial application or left us stuck in complicated and expensive structural design requirements for something we were assured would be a streamlined process. So far, the requirements asked of us have been in some cases more demanding than those I have previously encountered for a brand-new restaurant build-out! There has to be a better way. I beg you to read the attached letter and act quickly and decisively to alleviate the undue burden being placed on small neighborhood restaurants, many of which have already, or soon will have, been forced out of business.

As an historic neighborhood full-service diner owner in **Los Feliz**, we are in urgent need of relief from the current, overcomplicated process that continues to place undue financial and operational burdens on our business.

Outdoor dining has become essential to our survival. The **City of Los Angeles' AI Fresco Program**, while well-intentioned, has become bogged down in red tape, preventing many small businesses like ours from fully benefiting. The high costs and restrictive regulations are pushing us toward breaking point at a time when our industry is still grappling with the economic aftermath of the pandemic.

We were assured that the process to make the temporary AI Fresco permits permanent would be streamlined, but that has not been the case. In fact, the process seems more complicated, demanding and expensive than if we were commencing a brand-new restaurant build-out. We have been forced to spend tens of thousands of dollars on Architect's, Structural Engineer's and other fees, in addition to the substantial initial investment we made to build the outdoor space under the AI Fresco order. This has placed an undue, unexpected and unwelcome burden on us as we try desperately to recover from the pandemic and the additional strain that has been put on restaurants around the city due to the war in Ukraine, the supply chain issues and the movie industry strikes. We are fortunate to have had the funds set aside to cover these additional costs but there are hundreds of small restaurants not so fortunate and who will undoubtedly not survive the burden.

If these barriers aren't addressed immediately, we risk losing more local establishments, jobs, and vital community hubs. Our businesses are struggling now, and delays in simplifying the permitting process are not just costly—they're potentially fatal to the survival of small restaurants that have given so much to this city.
