The Board of Building and Safety Commissioners, at its meeting of October 15, 2024, gave consideration to the application by Arthur Boghossian, to export 3,990.63 cubic yards of earth from the above-referenced property.

The Board took the following action:

1. DETERMINED that the project is categorically exempt under CEQA pursuant to Section 15303 (Class 3) of the California Environmental Quality Act (CEQA) Guidelines (Case No. ENV-2017-1106-CE), and there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies.
2. APPROVED the application subject to all conditions specified in the Department's report dated October 9, 2024, with the following exceptions:
 - a. Item C.15 shall be added as follows:

Workers' vehicles must be parked off-site and workers transported to the site.
Worker's vehicles must not be parked on any narrow roads leading up to the project site.
