

organizations, schools, religious groups, volunteer service groups, public safety and environmental organizations.

Given that comment is to be submitted on or prior to September 12, 2023, and our next BCC Board Meeting is not until September 13, 2023, our Executive Committee met and is unanimously presently opposed to the Metro TCN program as there has not been adequate public outreach for a program that will have impacts across our City. We are concerned about both the impact of the program in terms of light pollution, and in terms of distracted driving, and ask that the September 14, 2023 hearing be postponed so that community groups such as ours and interested citizens may have the time needed to review staff reports and offer meaningful comment.
