

**ORDINANCE NO. \_\_\_\_\_**

An ordinance dedicating, accepting and establishing certain real property owned by the City of Los Angeles as part of the west side of Vineyard Avenue, a public street of said City.

**THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:**


Section 1. The City Council of the City of Los Angeles finds that the public interest, convenience and necessity require that an easement for public street purposes over the following described real property owned by the City be, and same is hereby dedicated, accepted and established as part of the west side of Vineyard Avenue, a public street of said City.

THAT PORTION OF LOT 43 IN BLOCK 1 OF ARLINGTON HEIGHTS TERRACE SUBDIVISION NO. 1, IN THE CITY OF LOS ANGELES, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, AS PER MAP RECORDED IN BOOK 9 PAGE 168 OF MAPS, IN THE OFFICE OF SAID COUNTY RECORDER, LYING EASTERLY AND SOUTHEASTERLY OF THE LINE DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHERLY LINE OF SAID LOT, WITH THE WESTERLY LINE OF THE EASTERLY 5.00 OF SAID LOT; THENCE SOUTHERLY ALONG SAID WESTERLY LINE TO THE BEGINNING OF A TANGENT CURVE, CONCAVING NORTHWESTERLY, HAVING A RADIUS OF 20.00 FEET AND BEING TANGENT AT ITS POINT OF ENDING TO THE SOUTHERLY LINE OF SAID LOT; THENCE SOUTHWESTERLY ALONG SAID CURVE TO SAID POINT OF ENDING.

Section 2. Pursuant to the provisions of Section 252 of the Charter of the City of Los Angeles, this ordinance shall become effective upon publication.


